Retrospective & Late Applications

For retrospective or late applications the fee is increased to cover the increased difficulty the verifier will have in establishing whether works either underway or completed comply with the plans, specifications and other information provided

Retrospective BW (work started but not complete)	200% of fee table below
Retrospective Demolition Warrant (as above)	£250.00
Late Completion Certificate (work complete – no BW obtained)	300% of fee table below
Late Completion Certificate (demolition/conversion only)	£400.00

Note:

- 1. Fees are subject to discounts when:
 - Certificate(s) provided by approved Certifiers of Design are submitted with а the warrant application
 - A verifier is informed, at the warrant application stage, of the intention to b use a Certifier of Design before the warrant is granted and/or
 - A verifier has been informed, at the warrant application stage, of the С intention to use a Certifier of Construction as part of the completion certificate that is to be submitted.

Where the intention is to use a Certifier of Design, details of the certifier and approved body, including registration numbers, should be confirmed on the building warrant application form. There is no requirement to provide details of an approved Certifier of Construction at this stage
