1.0 Purpose

1.1. This report proposes nominations of Conservative elected Council members for vacancies on two committees and an amendment to membership on a third committee.

- 2.2. To appoint Councillor Darren Lee to the vacancy on the Place Committee
- 2.3. To appoint Councillor Denis Coyne to the vacancy on the Planning Committee
- 2.4. To remove Councillor Darren Lee from membership of the Audit Committee and
- 2.5. To appoint Councillor Denis Coyne to the Audit Committee in Councillor Lee's place.

3.0 Considerations

- 3.1. The proposed changes to the Place and Planning Committee arise from vacancies which were left unfilled by Council in December 2019, when Councillor Benny took up the role of Leader of the Conservative Group following the resignation of Councillor Bill Mason. At that time Councillor Benny took up a number of appointments which were vacated by Councillor Mason but not all of the committee roles allocated to the Conservative group were filled. The report in December 2019 indicated that this matter would be revisited once the by-election had taken place.
- 3.2. In addition there is a proposal to remove Councillor Lee from the Audit Committee and appoint Councillor Coyne in his place.
- 3.3. These appointments retain the political balance which was previously agreed by Council and, if accepted, will apply from the date of the Council's decision.
