## Extract from The Personal Li cence (Scotland) Regulations 2007 (SSI 2007/77)

#### **Application for a Personal Licence**

- 1.—(1) A personal licence application or a personal licence renewal application is to be—
  - (a) in the form set out in Schedule 2; and
  - (b) accompanied by-
    - (i) evidence that the applicant possesses a licensing qualification; and
    - (ii) two photographs of the applicant which comply with paragraph (2) and one of which has a statement on it in accordance with paragraph (3).
  - (2) The two photographs of the applicant must—
    - (a) measure 45 millimetres by 35 millimetres;
    - (b) be on photographic paper;
    - (c) be taken against a light background; and
    - (d) show the full face of the applicant, without the applicant wearing sunglasses or any head covering (unless the applicant wears such a covering on account of a religious belief).
- (3) One photograph of the applicant must have on the back of it a statement by a person appearing to the Licensing Board to be a person of standing in the community, with the words "I certify that this is a true likeness of (*name of applicant*)", followed by the full name of the person endorsing the photograph.
- **2.** A personal licence application or a personal licence renewal application must be made in writing or, if the Licensing Board to which the application is made so agrees, by electronic transmission.

- 1. In terms of Section 73A(2) of the Licensing (Scotland) Act, 2005 (the Act) I wish to make a representation in relation to the application for a personal licence made by the abovenamed.
- 2. This representation asks that the Licensing Board consider the information contained in paragraphs 3-9 and the before coming to a decision as to whether or not to grant a personal licence to the applicant.
- 3. The applicant has declared a recent conviction for a serious driving offence
- 4. The offence convicted is a relevant offence for the purposes of the Licensing (Scotland) Act, 2005
- 5. The circumstances surrounding the conviction are detailed in the Police letter of representation and I am unable to add any further detail to this.
- 6. I have interviewed the applicant in relation to her application.
- During the interview I I found Ms Mcalpine to present as a frank and honest individual. I formed
  the opinion that she was genuinely remorseful, and that she showed insight and understanding
  in relation to the offence.
- 8. Taking into consideration all of the information available this application can not be granted under delegated powers.
- 9. The Board must satisfy themselves that no grounds for refusal of the personal licence exist prior to determination of the application.
