## Subject: Licensing (Scotland) Act, 2005, Section 68 Licensing Standards Officer - Report on Application for Extended Hours Webb Ellis Rugby World Cup – Japan 2019 - 4 Applications.

- 1. Section 69(1)(b) of The Licensing (Scotland) Act, 2005 requires that the Licensing Standards Officer for the area be notified of all Extended Hours Applications. Section 69(3) of the Act requires the licensing Standards Officer to submit a report setting out his comments on the application within
- 2. Having read the content of the 4 attached applications and having made such enquiry as necessary I would like to make the following comments.
- 3. The 4 applications all seek to bring forward the commencement hour for alcohol sales to 8:30 am on each of the following 4 days.
  - 1. Sunday 22 September, 2019
  - 2. Saturday 26 October, 2019
  - 3. Sunday 27 October, 2019
  - 4. Saturday 2 November, 2019
- 4. The extension of hours is to facilitate the sale of alcohol on the premises whilst showing live television transmissions of key matches forming part of the Rugby World Cup tournament in Japan.
- 5. A special event to be catered for on the premises will take place on each of the above dates, and will involved opening the premises to an invited audience holding tickets.
- 6. The applicant explains fully on his application that he is seeking these extended hours to allow the sale of alcohol to a restricted number of invited quests/ticket holders whilst televising these matches on the premises. Food will be provided as part of the event.

- 7. The proposed extension falls outside the Licensing Board Policy in relation to licensed hours, and in the circumstances it is a matter for the Board to decide whether or not to grant the application.
- 8. There are no concerns relating to public order, public safety, public nuisance or the welfare and protection from harm of children and young persons.
- 9. Similar hours to those sought in these applications were granted by the Licensing Board, in relation to the British Lions Rugby Tour of New Zealand in 2017. Those applications were granted subject to a number of local conditions.
- 10. It may be that the Licensing Board would again wish to add a number of local conditions to the extended hours period which would ensure that the event is run in accordance with the terms of the application and the additional information provided by the applicant.
- 11. At **appendix A** I have created a list of suggested local conditions, all or some of which the board may consider appropriate to impose in the circumstances. I can advise that the applicant has had sight of these suggested local conditions and has stated that they would cause him no operating difficulty in relation to this event.
- 12. I have no concerns or adverse comments to make in relation to this application.
- 13.1 am satisfied that the event is a special event or occasion to be catered for on the premises in the terms of section 68(1)(b(i) of the Licensing (Scotland) Act, 2005.




