#### PLA033 PLANNING APPLICATION - AMENDED PROPOSALS

Application for amended proposals to Planning Permission Ref No. 12/00021/FULL at Speirs Centre, Alloa (Ref No. 12/00278/FULL) - Alteration, Extension and Partial Change of Use of Indoor Sports Centre (Class 11) to Library (Class 10), with Associated External Works, including Access Ramp.
