# PLA(16)09 PLANNING APPLICATION

#### Application for Planning Permission – Installation of 15m Telecommunication Streetpole, Antennas and 3 Cabinets at Land East of Junction of Windsor Gardens and Fairyburn Road, Tullibody, Alloa, Clackmannanshire (Ref. No. 16/00063/FULL)

A report which comprised the Report of Handling on the above planning application and made recommendations to the Committee was submitted by the Principal Planner. The purpose of the report of handling was to provide an assessment of and recommendations on the development proposals for the installation of a telecommunications streetpole with 3 antennas and 3 cabinets on the grass verge at the above location.

The proposal is for a Local Development which would normally be determined by Appointed Officers.
