The new policy is: Children whose parents can demonstrate affiliation to the Roman Catholic church, by means of a baptismal certificate, and who live in the geographical catchment are, are entitled to enrol in the school. Parents who are not entitled to automatic admission can apply via the placing request mechanism.
- 4. Agree that changes to the admissions policy should only apply to children who do not currently attend either school or the siblings of children who currently attend either school.
