- 8. The Convenor will bring the meeting to a close by advising all petitioners that the Committee's decision will be notified in writing to the Principal Petitioner within 7 working days. All petitioners will then be asked to withdraw from the meeting.
- The Committee will debate and decide on the most appropriate course of action.
 Council officers will be present and the Committee can ask officers questions to inform their decision making.
- 10. The Committee will report on every petition, in respect of which it has heard representations, to Council with its recommendation on how the petition should be disposed of, which could include:
 - Agreeing that the issue raised does not merit further action at this stage
 - Instructing an officer to complete an investigation and submit a report with recommendations on the disposal of the petition to a future Council meeting.

1.0 Purpose

1.1. The report summarises the petition which has been received following the budget consultation process in respect of matters which fall within the remit of the Place Committee. The full petition does not accompany this report but the original paper copy will be available for inspection by the Committee.

2.0 Recommendations

2.1. It is recommended that the Committee hear from the petitioners, seeking information from them as appropriate, and then prepare a report to Council on how the petition is disposed of.

3.0 Considerations

3.1. Clackmannanshire Citizens Advice Bureau

The petition is in paper form and has been verified with 242 signatures of people living in the Clackmannanshire Council area. A number of signatures have been discounted as they are of people living outwith the Council area. There is also a change.org petition which has been verified with 319 signatures of people living in the Clackmannanshire area. Taken together there are a total of 561 signatories.

The name of the principal petitioner is Jane Greig. She meets the principal petitioner criteria. Ms Greig has been invited to attend the Committee.

The title of the petition is "Save Clackmannanshire Citizens Advice Bureau". The information contained in the petition statement is as follows:

"Clackmannanshire Council are proposing to cease funding to the bureau resulting in closure and no advice provision to individuals across the community. We currently deal with almost 20,000 advice issues per year and bring in excess of 3 million to the local economy each year, this will also result in to the loss of 26 jobs."
