Subject: Support to Voluntary Organisations

1.0 Issue

- 1.1. The corona virus is placing unprecedented demands on local voluntary organisations working tirelessly to provide support to individuals in our community. CTSI has been working to support local organisations but has identified a need to provide ongoing support to groups to assist with volunteer costs, such as fuel, equipment and in some instances food and other daily essentials. CTSI has already provided £500 of emergency funding to many of these community groups this week, and has asked if the Council can assist with further booster funding to ensure ongoing sustainability of these efforts until such times that other sources of national funding become readily available.
- 1.2. I have consulted with CTSI, and a sum of £20,000 is believed to be sufficient at this stage. Clackmannanshire Council was awarded a £465,000 Hardship Fund. Having consulted with the Chief Finance Officer, I believe that there is a case to use the Hardship Fund for this purpose.

2.0 Options and Impacts

2.1. Option 1

Provide an initial £20,000 funding from the Hardship Fund for the purpose outlined above. This could be reviewed in due course if necessary. The funding would be retained by the Council but released quickly in batches of up to £5,000 as requested by CTSI to disburse as need dictates.

Given these are trusted community groups already providing vital services at pace in a complex and ever changing environment, CTSI are in the process of putting in place a light touch monitoring system, e.g. asking groups to keep receipts for any expenditure but not detailed records. Given it is a trusted partner, it is suggested that we avoid additional monitoring and evidence demands above what CTSI is already putting in place.

Impact

This funding will allow these voluntary organisations to continue to provide vital and valued services to the community in the short term until such times as other, planned funding sources come on stream.

This support will assist the Council in its role as a Category 1 responder under the Civil Contingencies legislation, and continues the Council's transformational aspirations to widen and develop its support for community resilience initiatives.
