- This Order may be cited as "The Clackmannanshire Council (Menstrie Road, Tullibody) (Temporary Closure) Order 2013" and notwithstanding the date hereof shall come into operation on the 8th July 2013.
- The effect of this Order shall be to close to vehicles:-The period from 0800 hours on Monday, 8th July 2013 until 1700 hours on Friday, 12th July 2013 on the section described in the Schedule attached. The temporary closure is necessary for resurfacing works.
