

(VARIOUS ROADS, CLACKMANNANSHIRE) (30 MPH SPEED LIMIT) CONSOLIDATION ORDER 2013

Clackmannanshire Council, in exercise of the powers conferred upon it by Section 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Order may be cited as "The Clackmannanshire Council (Various Roads, Clackmannanshire) (30 mph Speed Limit) Consolidation Order 2013" and shall come into operation on the 9th September 2013.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (3) This Order revokes:
 - The Clackmannanshire Council (Various Roads, Clackmannanshire) (30 mph Speed Limit) Consolidation Order 2012.
- (4) A speed limit of 30 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the said lengths of roads.

(5) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

These 30 MPH limits are considered necessary in the interests of road safety, and will
ensure that traffic speeds are limited to a speed compatible with the local environment.
