- 1. This Order may be cited as "The Clackmannanshire Council (Balcarres Street, Tillicoultry) (Temporary Closure) Order 2013" and notwithstanding the date hereof shall come into operation on the 5th September 2013.
- 2. The effect of this Order shall be to close to vehicles:-
