

(INDUSTRIAL RELIEF ROAD, ALLOA) (TEMPORARY WAITING RESTRICTION) ORDER 2013

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Industrial Relief Road, Alloa) (Temporary Waiting Restriction) Order 2013" and notwithstanding the date hereof shall come into operation on the 5th November 2013.
- 2. The effect of this Order shall be that no waiting restrictions will be applicable during:-The period from 1700 hours on Tuesday 5th November 2013 until 2100 hours on Tuesday 5th November 2013 on the section described in the Schedule attached. The temporary waiting restriction is necessary for public safety during the Firework display.
