



**(VARIOUS STREETS, ALLOA)

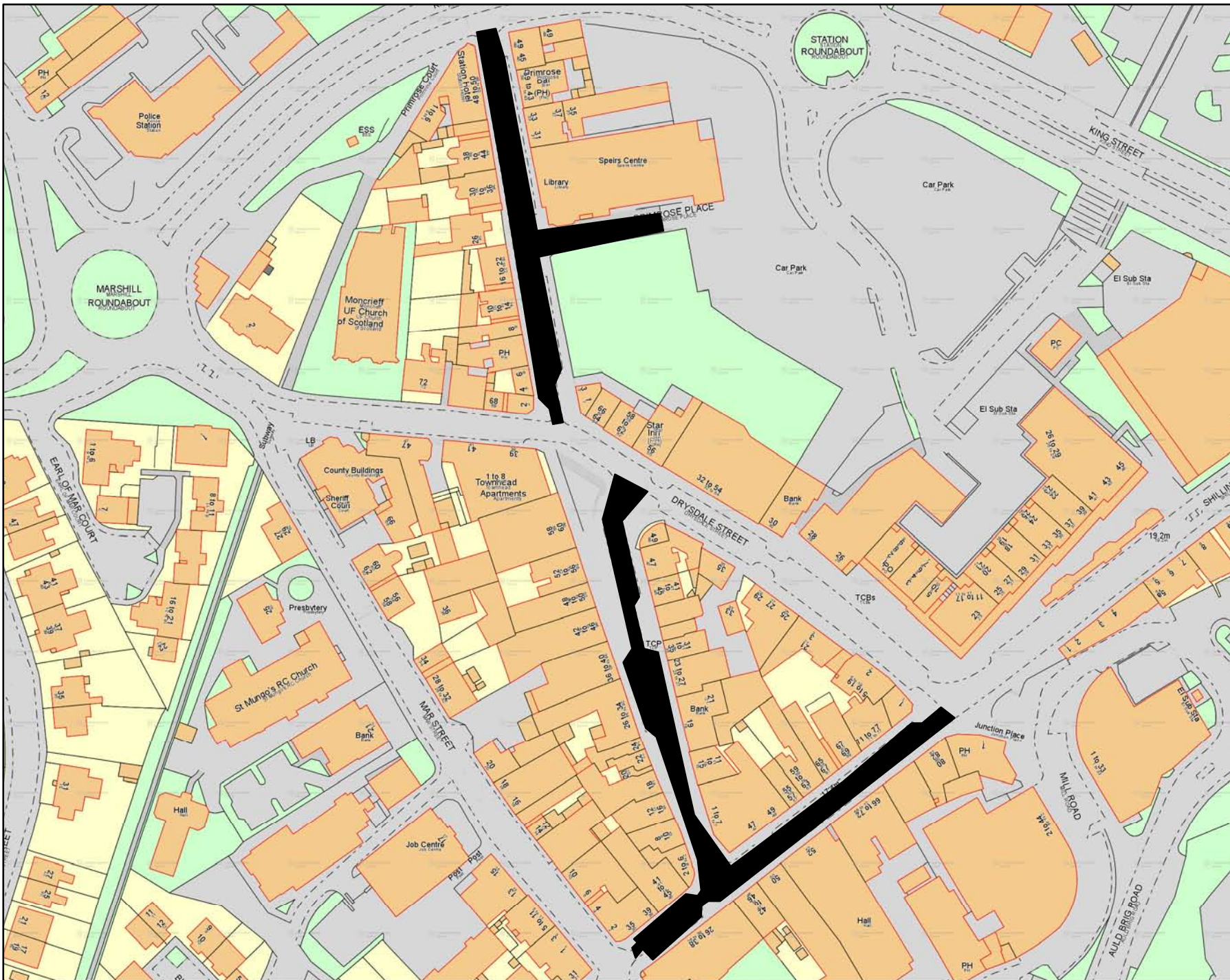
