



**(B908 PARKWAY, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation on the 9th February 2017.
2. The effect of this Order shall be to close to vehicles:-
The period from 0730 hours until 1400 hours on Sunday 19th March 2017 on the section described in the Schedule attached. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon at the start and finish lines.

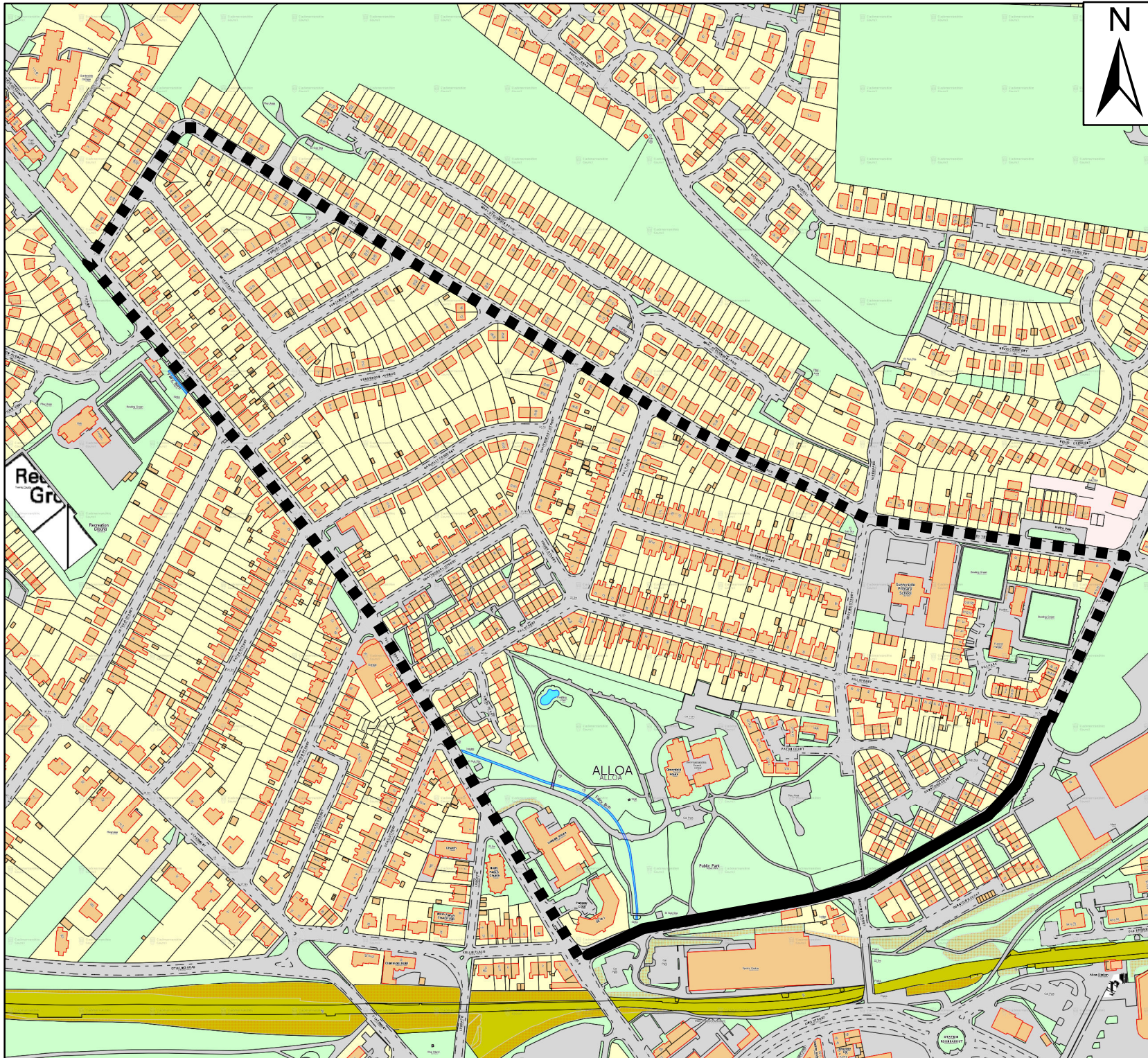
