



**(PARK STREET, ALVA)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Park Street, Alva) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Wednesday 30th August 2017 and will remain in operation for 5 days.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Wednesday 30th August 2017 for a period of 5 days or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary for installation of new foul water manhole and associated pipework for a new housing development.

The Council has made "The Clackmannanshire Council (Park Street, Alva) (Temporary Road Closure) Order 2017, under the Road Traffic Regulation Act 1984 (as amended) on 8th August 2017: to close to vehicles the section of road at **Park Street** (from its junction with Copland Street eastwards until with Queen Street, a distance of 140 metres or thereby), Diversion: via Copland Street, Stirling Road, Queen Street and vice versa. The order runs from 0800 hours on Wednesday 30th August 2017 for a period of 5 days or until works are completed whichever is soonest. The works are necessary for installation of new foul water manhole and associated pipework for a new housing development. 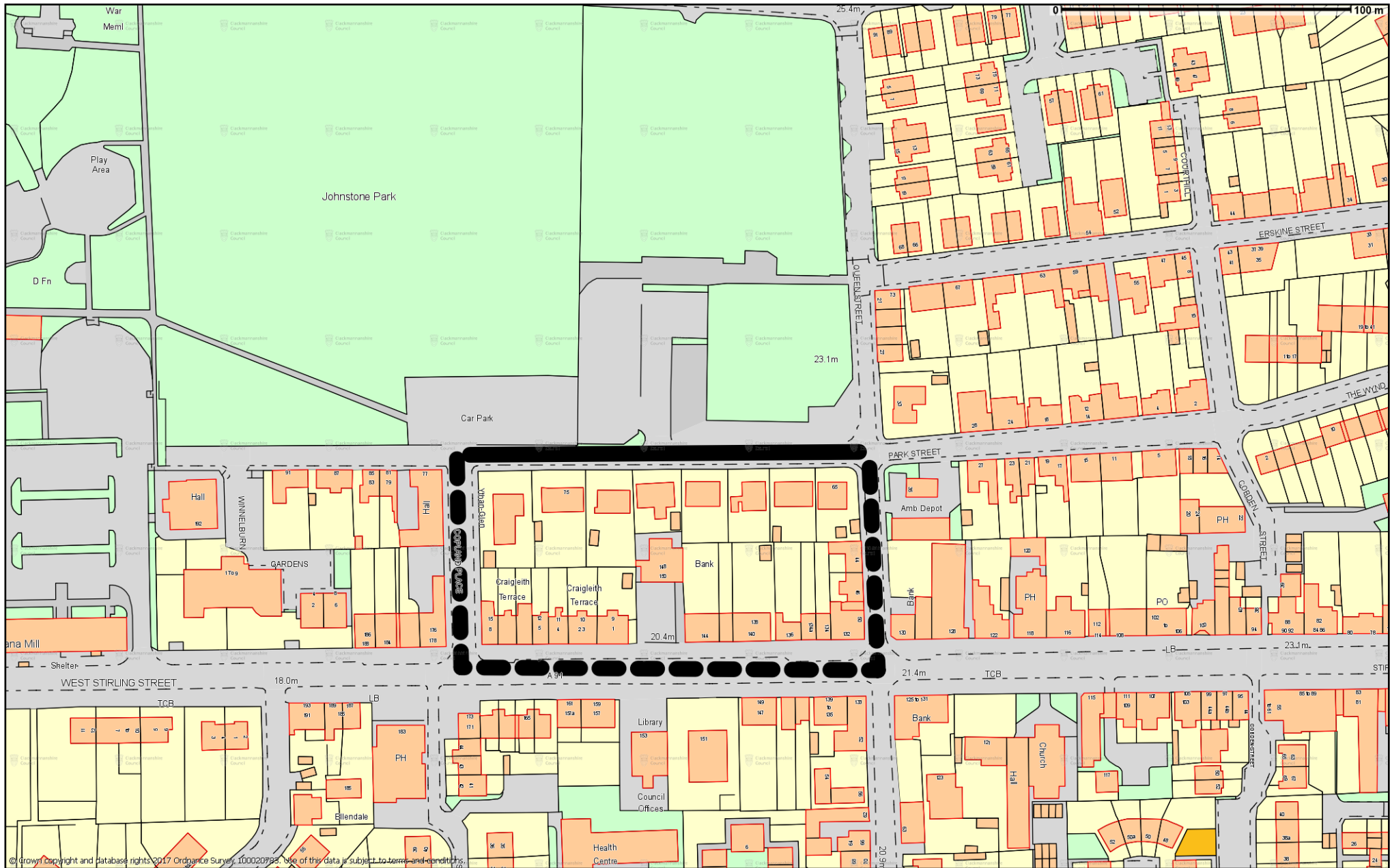
