



**(ALLOA ROAD, TULLIBODY)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Alloa Road, Tullibody) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 15th January 2018 and will remain in operation until 1700 hours on Sunday 4th February 2018.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 15th January 2018 until 1700 hours on Sunday 4th February 2018, on the section of roads described in Schedule. The temporary closure is necessary to excavate track to lay new lighting.


