



**(BRANSHILL PARK, SAUCHIE)
(TEMPORARY FOOTWAY CLOSURE) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Branshill Park, Sauchie) (Temporary Footway Closure) Order 2018" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 29th February 2018 and will remain for 3 months.

2. The effect of this Order shall be to close to pedestrians:-
 The period from 0800 hours for a period of 3 months or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary footway closure is necessary for wall replacement. Each section will be done in phases, therefore closures will happen at some point during the timescale given. Notice will be given to residents.

The order runs from 0800 hours on Monday 29th February 2018 for a period of 3 months or until works are completed whichever is soonest, and is necessary for wall replacement. Each section will be done in phases, therefore closure will happen at some point during the timescales given. Notice will be given to residents. 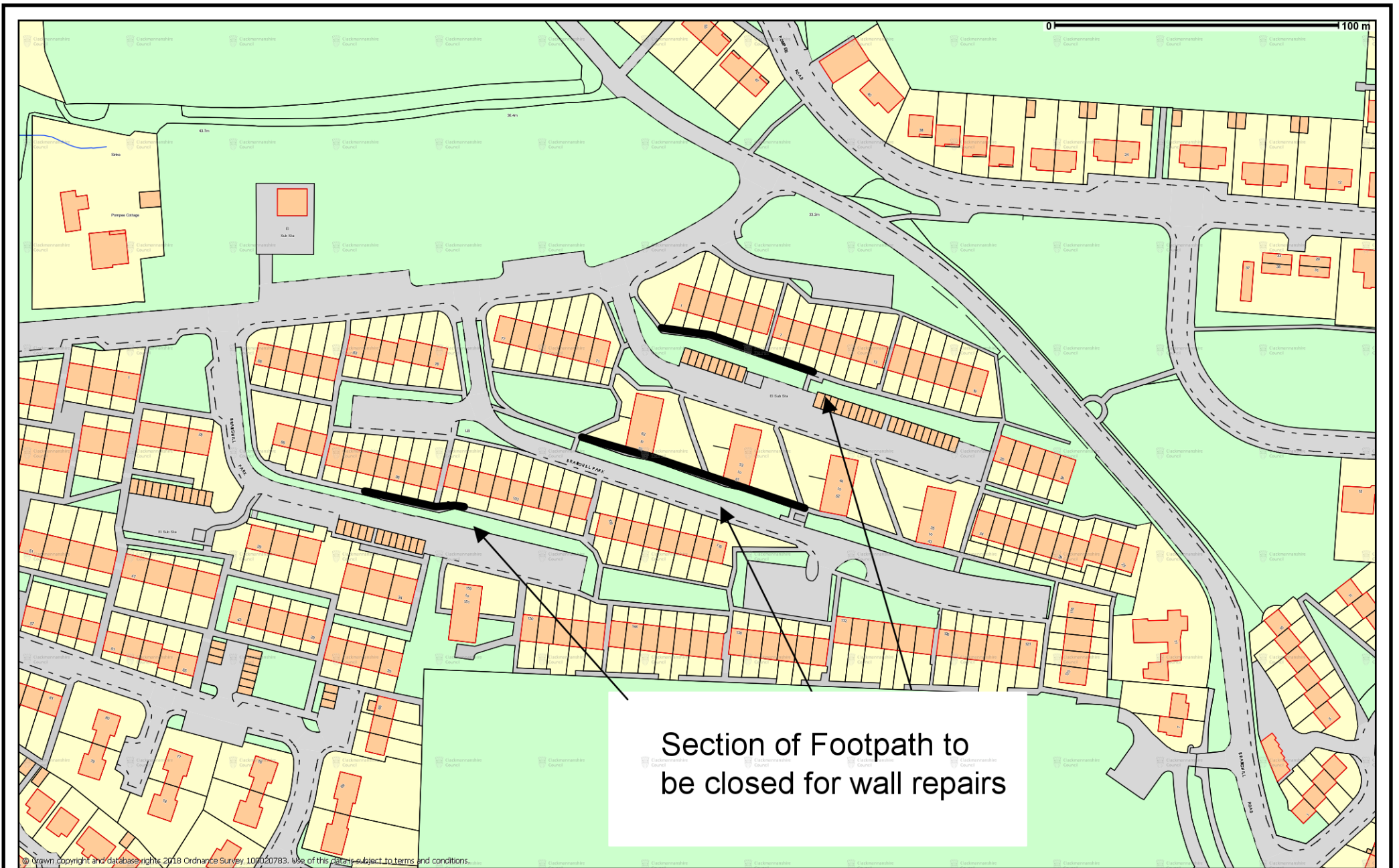
