The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (B9096 Tullibody Road, Alloa and Pitfairn Road, Fishcross) (Temporary No Waiting Restriction) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 9th July 2018 and will remain for 1 day.
- 2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 0800 hours on Monday 9th July 2018 for a period of 1 day or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary no waiting or loading is required for resurfacing works.

The Council has made "The Clackmannanshire Council (B9096 Tullibody Road, Alloa and Pitfairn Road, Fishcross) (Temporary No Waiting Restriction) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 4th June 2018: to where there will be no waiting at **B9096 Tullibody Road, Alloa** from a point 20 metres or thereby north of its junction with Thorne Road southwards for a distance of 515 metres or thereby. **Pitfairn Road, Fishcross** from its junction with Burnee eastwards for a distance of 190 metres or thereby. The order runs from 0800 hours on Monday 9th July 2018 for a period of 1 day or until works are completed whichever is soonest. The works are required for resurfacing works.
