

(VARIOUS STREETS, ALVA) (TEMPORARY ROAD CLOSURE) ORDER 2018

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 30th July 2018 and will remain in operation for a period of 6 weeks.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 30th July 2018 for a period of 6 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary to allow installation of new gullies and street lighting system. Resurfacing of roads and installation of speed table.

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Road Closure) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 28th June 2018: to close to vehicles the section of road at **Queen Street**, **Alva -** from its junction with A91 Stirling Street, northwards until its junction with Erskine Street a distance of 130 metres or thereby, **Park Street**, **Alva -** from its junction with Copland Place eastwards until its junction with Cobden Street, a distance of 260 metres or thereby. The order runs from 0800 hours on Monday 30th July 2018 for a period of 6 weeks or until works are completed whichever is soonest. The works are necessary to allow installation of new gullies and street lighting system. Resurfacing of roads and installation of speed table.
