



**(CLAREMONT, ALLOA)  
(TEMPORARY ROAD CLOSURE) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Claremont, Alloa) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 20<sup>th</sup> August 2018 and will remain in operation for a period of 5 days.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 20<sup>th</sup> August 2018 for a period of 5 days or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary to allow resurfacing, kerbing and drainage works. It also allows safety of the workforce.

### **The Clackmannanshire Council (Claremont, Alloa) (Temporary Road Closure) Order 2018**

The Council has made "The Clackmannanshire Council (Claremont, Alloa) (Temporary Road Closure) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 11<sup>th</sup> July 2018: to close to vehicles the section of road at **Claremont, Alloa** – from a point 40 metres or thereby west of its junction with Churchill Street, westwards for a distance of 250 metres or thereby. Diversion: via Gean Road, Eden Road, Churchill Street and vice versa. The order runs from 0800 hours on Monday 20<sup>th</sup> August 2018 for a period of 5 days or until works are completed whichever is soonest. The works are necessary to allow resurfacing, kerbing and drainage works. It also allows for safety of the workforce. 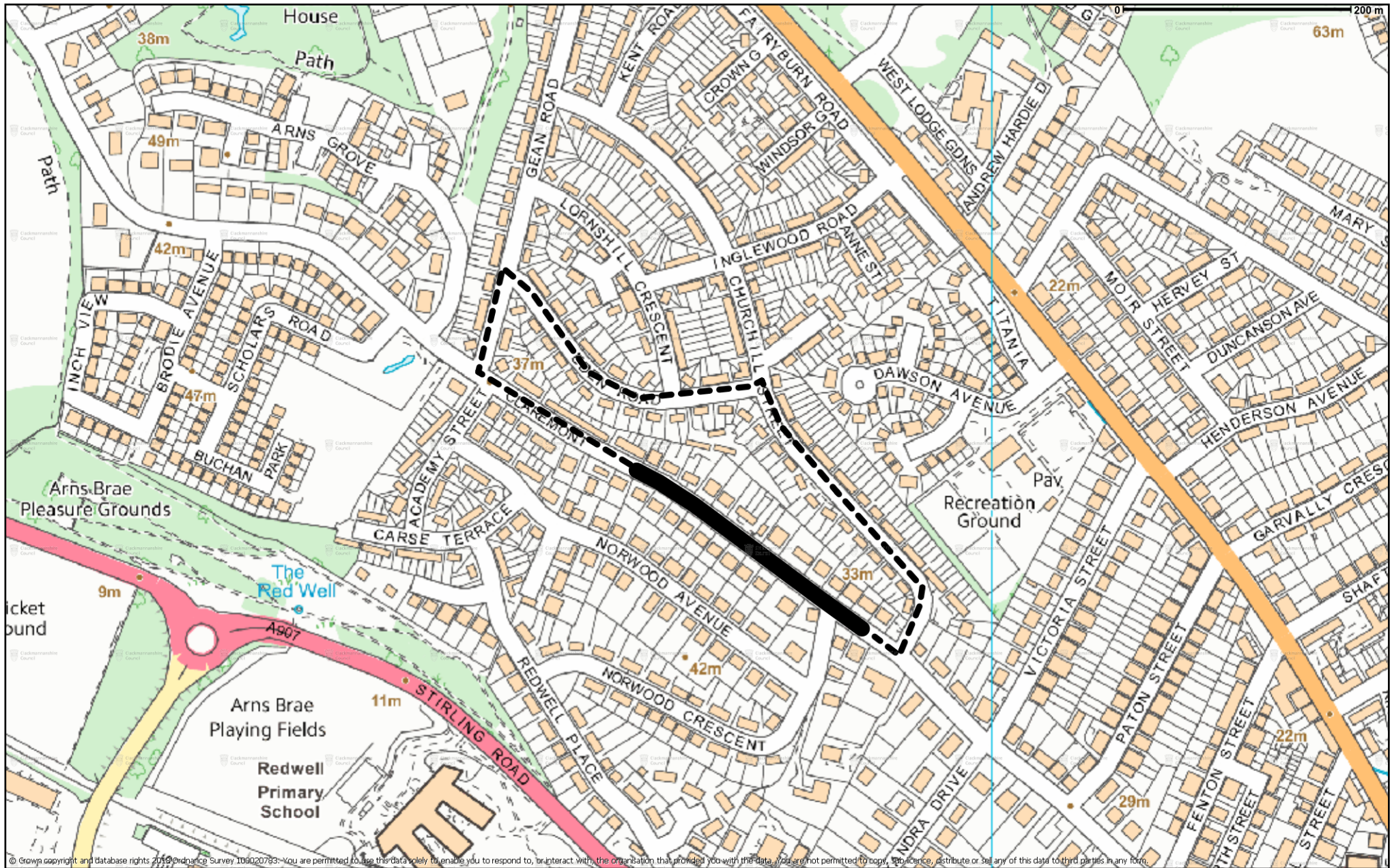
