



**(WALTON CRESCENT, DOLLAR)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Walton Crescent, Dollar) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours on Monday 20<sup>th</sup> August 2018 until 1530 hours on Monday 20<sup>th</sup> August 2018.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours until 1530 hours on Monday 20<sup>th</sup> August 2018, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to allow Keir to carry out repairs on damaged iron works. Pedestrian and emergency vehicular access to premises will be maintained where possible.

The Council has made "The Clackmannanshire Council Walton Crescent, Dollar) (Temporary Prohibition of Driving, Parking and Loading) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 2 August 2018: where there will be a temporary prohibition of driving, parking and loading at **Walton Crescent, Dollar** (from its junction with Malcolm Court southwards for a distance of 52 metres or thereby) There will be a diversion via Malcolm Court and vice versa. The order runs from 0800 hours until 1530 hours on Monday 20th August 2018. The works are required to allow Keir to carry out repairs on damaged iron works. 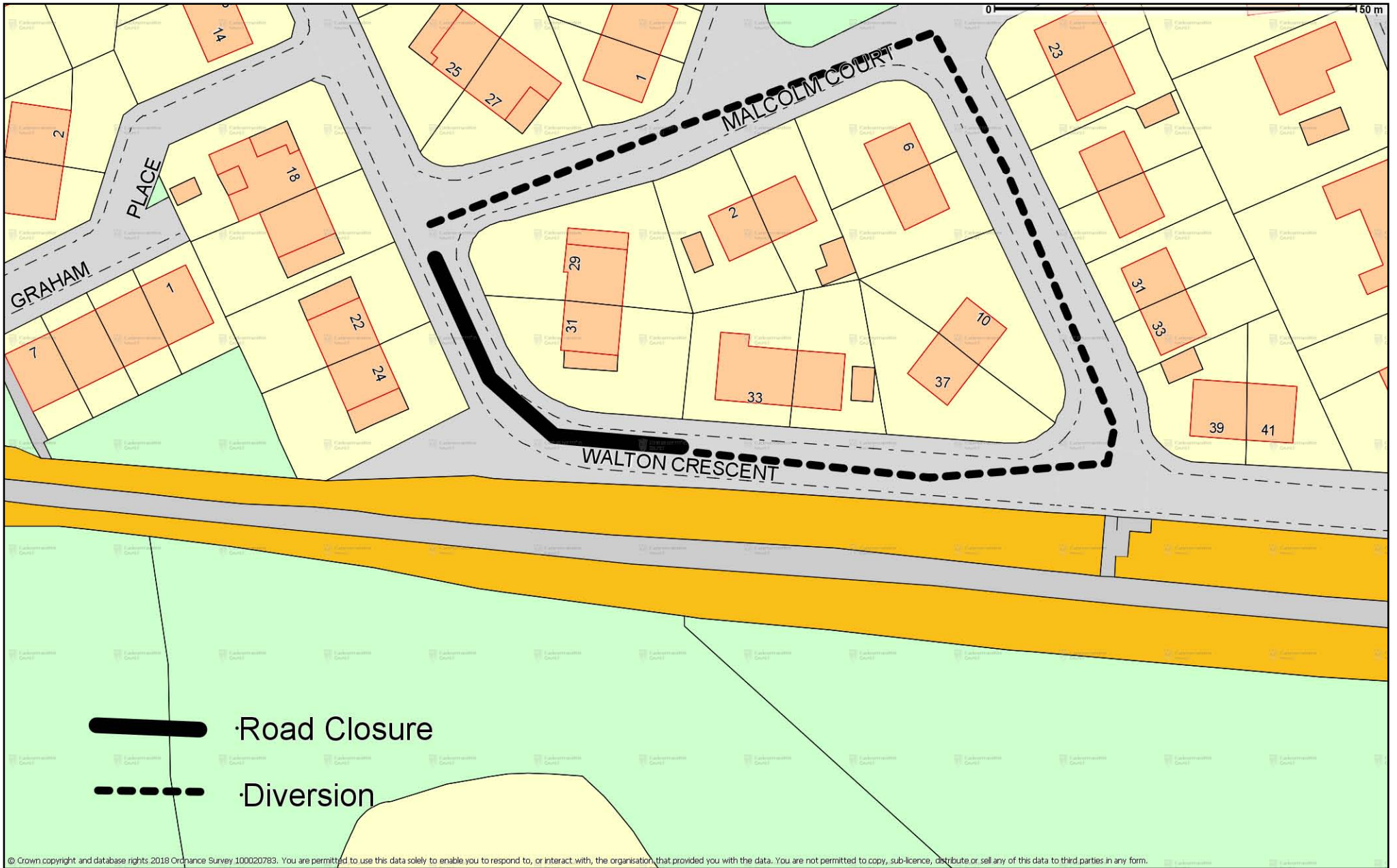

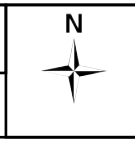
