



**(THE BRAES, TULLIBODY)
(TEMPORARY FOOTWAY CLOSURE AND TEMPORARY
NO WAITING OR LOADING RESTRICTION) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (The Braes, Tullibody) (Temporary Footway Closure and Temporary No Waiting or Loading Restriction) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 3rd September 2017 and will remain for one week.
2. The effect of this Order is that the footway will be closed and there shall be no waiting or loading at any time during:-

The period from 0800 hours on Monday 3rd September 2018 for a period of one week or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary footway closure and the temporary no waiting or loading is required to allow resurfacing works to take place and for the safety of the workforce.

The Council has made "The Clackmannanshire Council (The Braes, Tullibody) (Temporary Footway Closure and Temporary No Waiting or Loading Restriction) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 8th August 2018: where there will be a temporary footway closure and no waiting or loading at **The Braes, Tullibody** (Both sides - from its junction Muirside Road eastwards for a distance of 175 metres or thereby). The order runs from 0800 hours on Monday 3rd September 2018 for a period of one week or until works are completed whichever is soonest. The works are required to allow resurfacing works to take place and for the safety of the workforce. 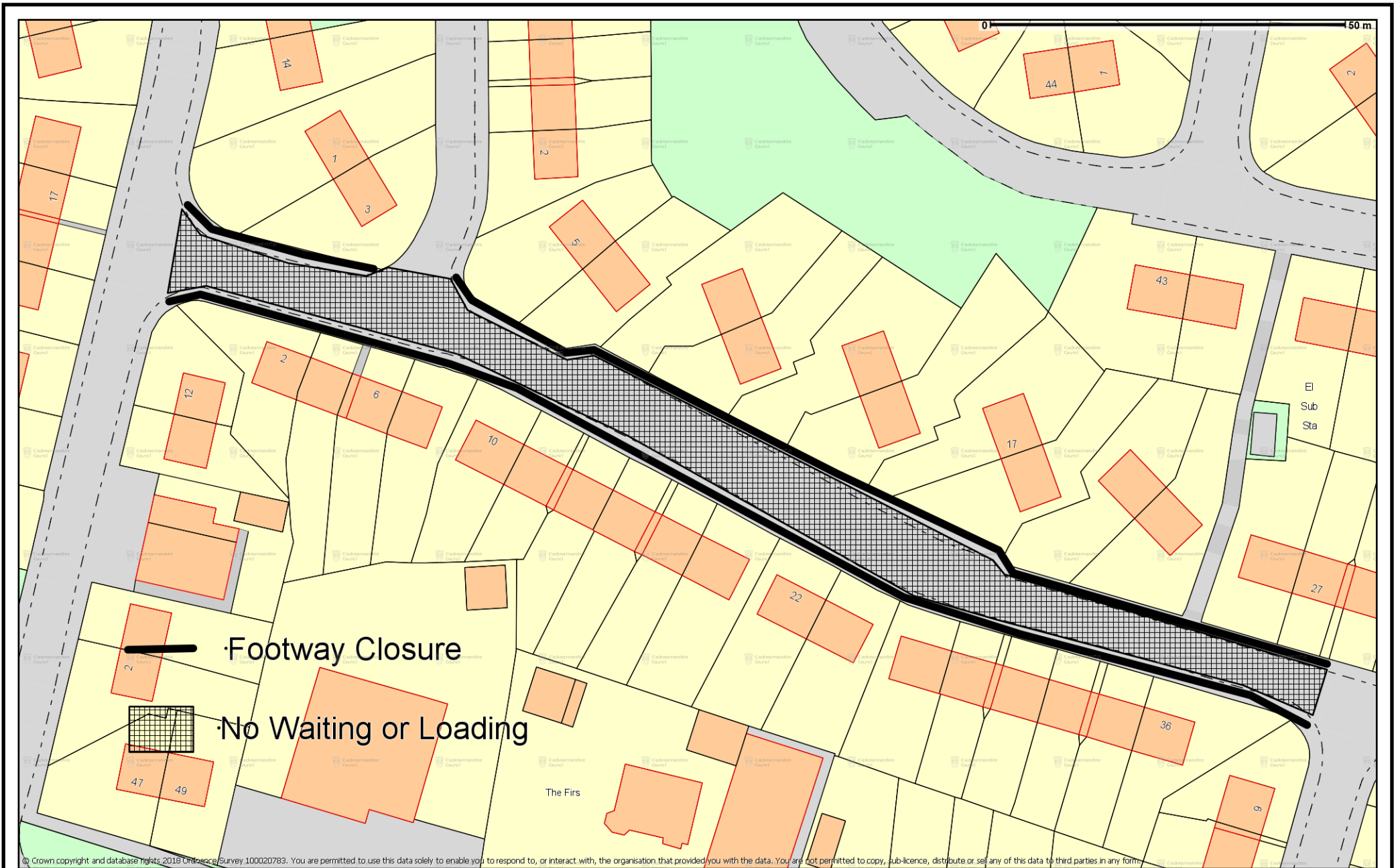
