

(OCHIL STREET, TULLIBODY) (TEMPORARY FOOTPATH CLOSURE) ORDER 2018

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Ochil Street, Tullibody) (Temporary Footpath Closure) Order 2018" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 10th September 2018 and will remain for 1 week.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 10th September 2018 for a period of 1 week or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary footpath closure is necessary to allow the footpath to be upgraded. It also allows for safety of the workforce.

The Council has made "The Clackmannanshire Council (Ochil Street, Tullibody) (Temporary Footpath Closure) Order 2018", under the Road Traffic Regulation Act 1984 (as amended) on 12th July 2018: to close to pedestrians at **Ochil Street, Tullibody** (footpath from No. 2 Ochil Street to near No. 24 Newmills including spurs to near No. 22 Baingle Brae and No. 8 Ochil Street, a distance of 170 metres or thereby), (Footpath from outside No. 22 Baingle Brae to the rear of No. 8 Ochil Street, a distance of 68 metres of thereby), (Footpath from front of No. 2 Ochil Street to front of No. 8 Ochil Street, a distance of 35 metres or thereby), (Footpath from rear of No. 2 Ochil Street to rear of No. 8 Ochil Street, a distance of 35 metres or thereby), (Footpath from rear of No. 2 Ochil Street to rear of No. 8 Ochil Street, a distance of 35 metres or thereby), (Footpath from No. 30 Ochil Street northwards, 10 metres north of No. 32 Ochil Street, a distance of 27 metres or thereby).
