



**(VARIOUS STREETS, TILlicOUNTRY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 17th September 2018 for a period of 2 weeks.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 17th September 2018 for a period of 2 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow the road to be resurfaced. Resident access will be maintained where possible.

The Council has made "The Clackmannanshire Council (Various Streets, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 23rd August 2018: where there will be a temporary prohibition of driving, parking and loading at **Cunninghar Drive** (for its entirety, a distance of 160 metres or thereby), **Elmwood Avenue** (for its entirety, a distance of 85 metres or thereby), **Johnston Crescent** (from its junction with Cunninghar Drive southwards for a distance of 60 metres or thereby). The order runs from 0800 hours on Monday 17th September 2018. The works are necessary to allow the road to be resurfaced. Residents access will be maintained where possible. 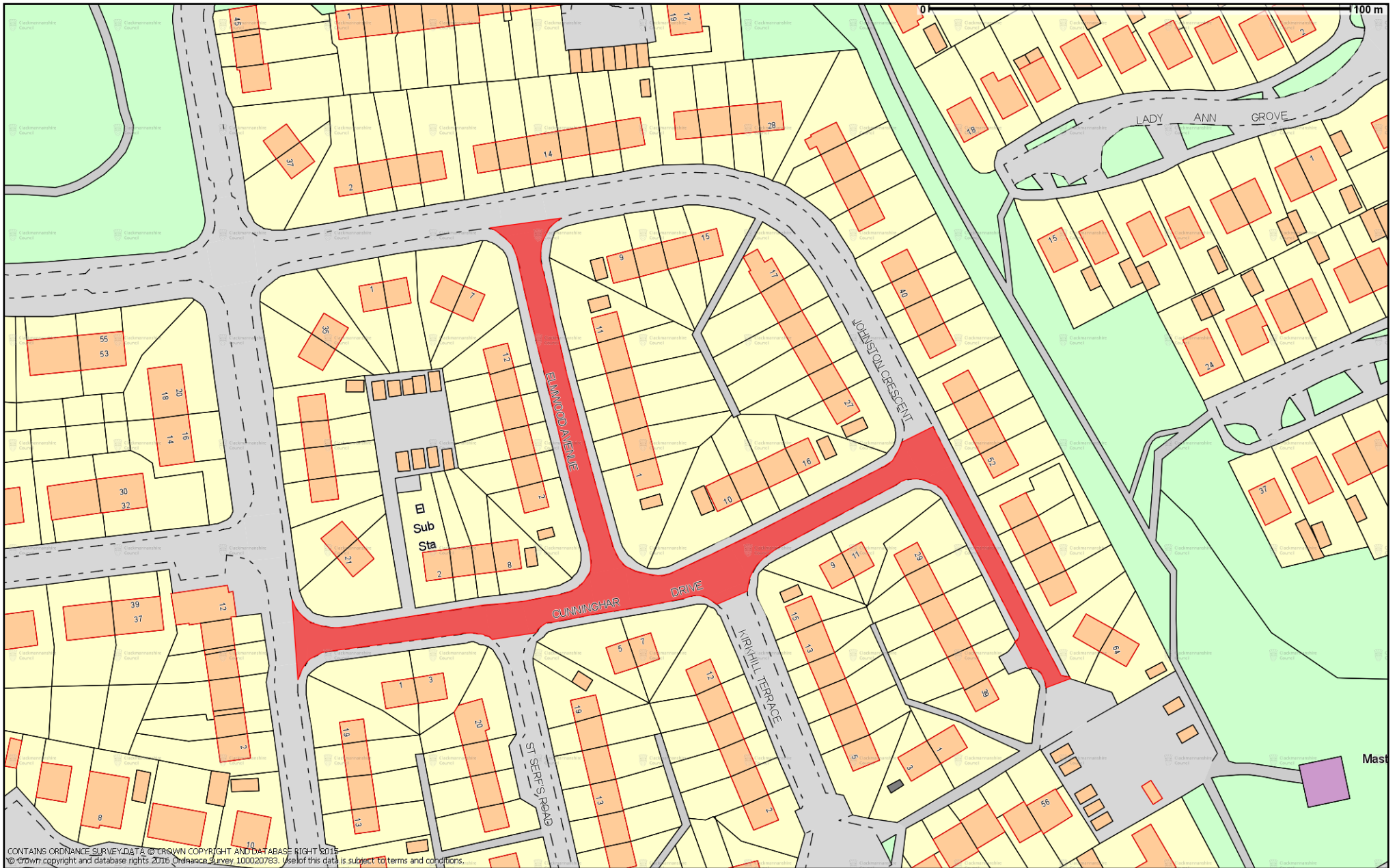
