



**(VARIOUS STREETS, ALLOA)
(TEMPORARY REVOCATION OF ONE WAY SYSTEM) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Revocation of One Way) Order 2018" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 1st October 2018 and will remain in operation for a period of 2 weeks.
2. The effect of this Order shall be to suspend one way during:-

The period from 0800 hours on Monday 1st October 2018 for a period of 2 weeks or until works are completed whichever is soonest, on the sections of roads described in Schedule. The temporary revocation of one way is to allow 2 way vehicle movement during resurfacing works.

The Clackmannanshire Council (Various Streets, Alloa) (Temporary Revocation of One Way) Order 2018

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Revocation of One Way) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 29th August 2018: to suspend one way traffic at **Ludgate** – from its junction with Kellie Place until its junction with Tullibody, a distance of 110 metres or thereby. **Garvally Crescent** – from its junction with Tullibody Road until its junction with Shaftsbury Street, a distance of 215 metres or thereby. The order runs from 0800 hours on Monday 1st October 2018 for a period of 2 weeks or until works are completed whichever is soonest and is to allow 2 way vehicle movement during resurfacing works. 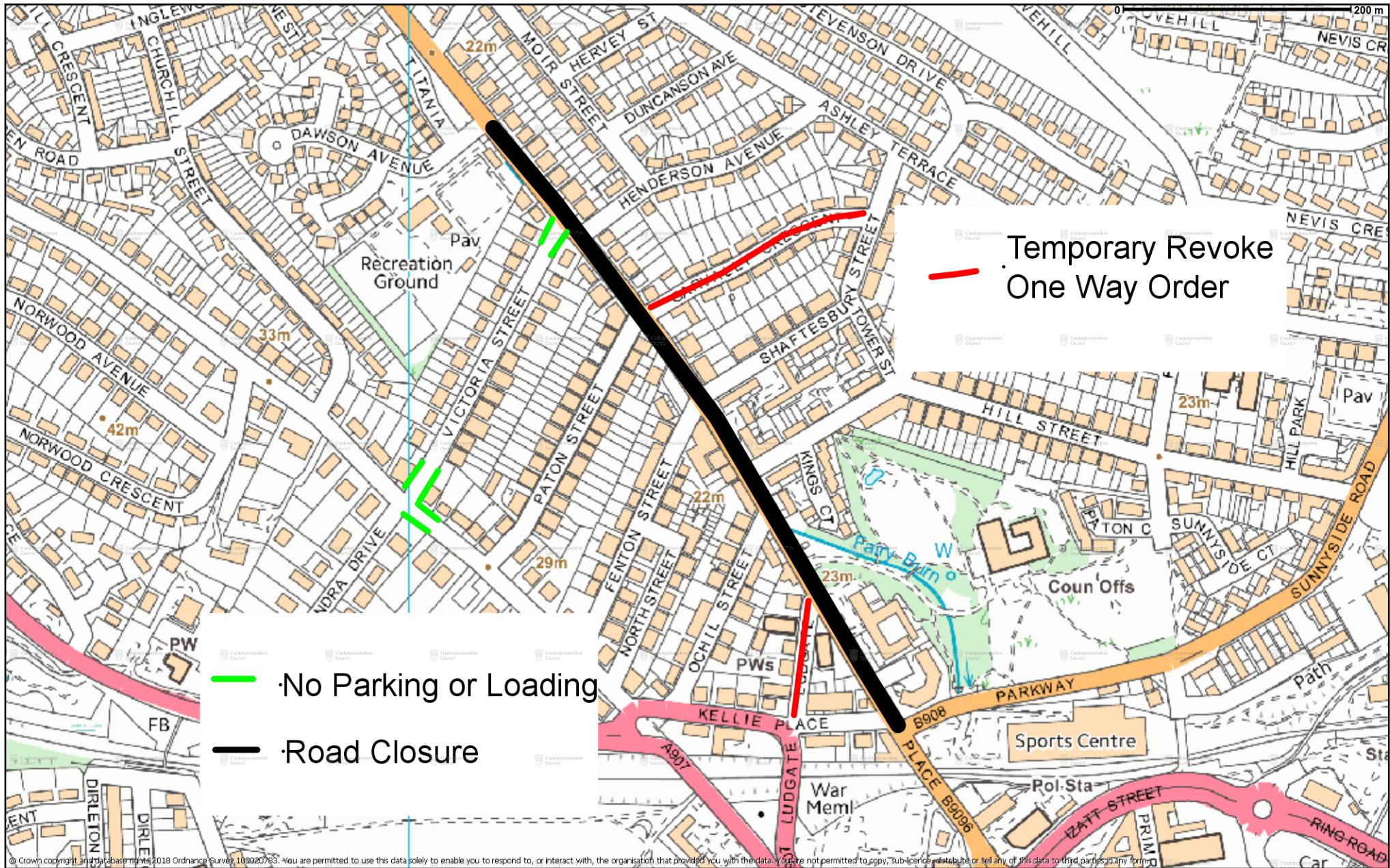
