



**(TULLIBODY ROAD, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Tullibody Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 1st October 2018 for a period of 2 weeks.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 1st October 2018 for a period of 2 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow the road to be resurfaced. Works will be completed over 2 phases, diversion will be signed where appropriate.

The Council has made "The Clackmannanshire Council (Tullibody Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 29th August 2018: where there will be a temporary prohibition of driving, parking and loading at **Tullibody Road, Alloa** (from its junction with Dawson Avenue eastwards until its junction with Parkway, a distance of 635 metres or thereby). Diversion: Via A907 or B9140. The order runs from 0800 hours on Monday 1st October 2018 for a period of 2 weeks or until works are completed whichever is soonest. The works are necessary to allow the road to be resurfaced. Works will be completed over 2 phases, diversion will be signed where appropriate. 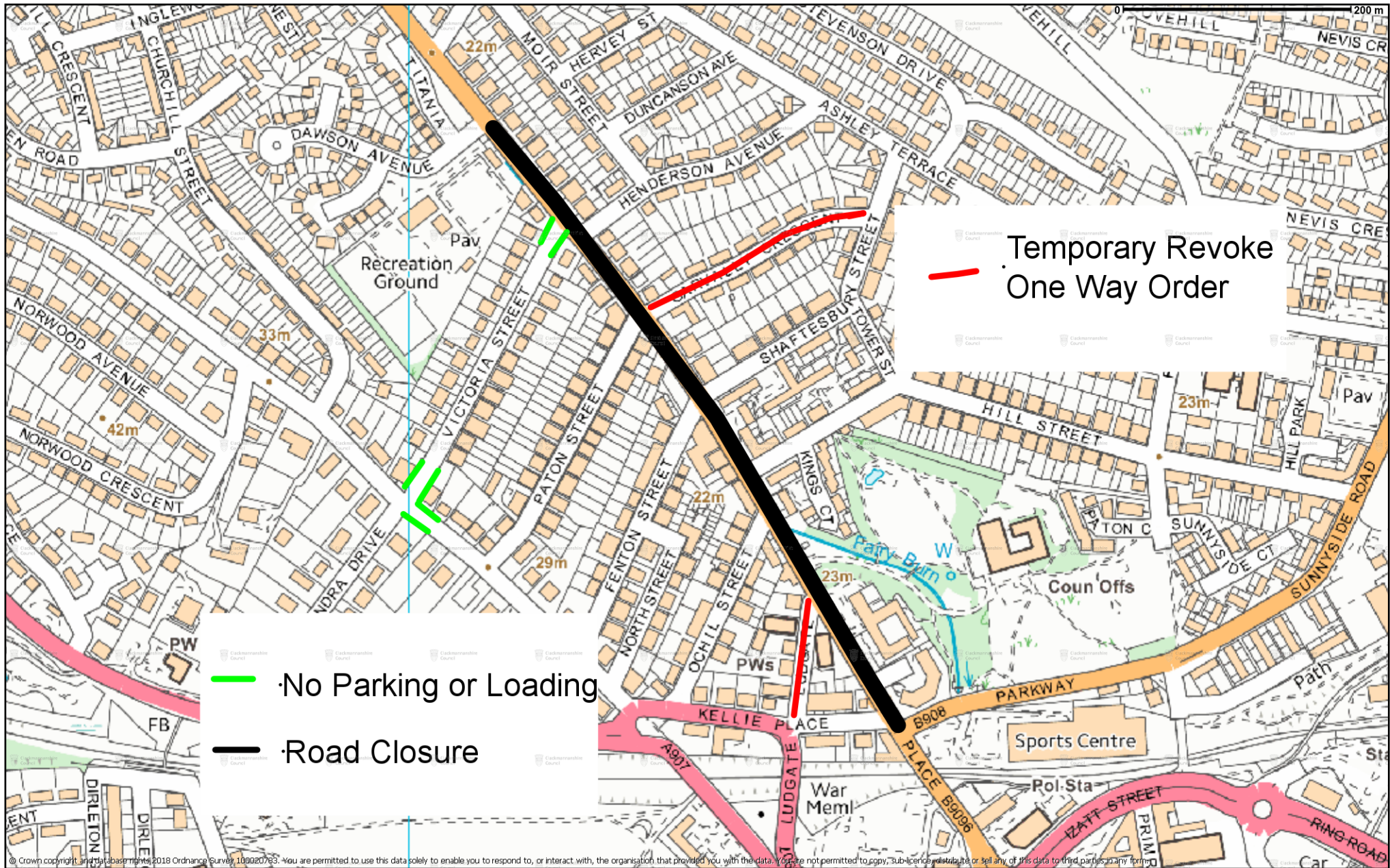

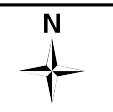
