



**(LOWER MILL STREET, TILlicOUNTRY)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Lower Mill Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 1<sup>st</sup> October 2018 for a period of 1 week.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 1<sup>st</sup> October 2018 for a period of 1 week or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow the drainage works to be carried out. Diversion will be signed where appropriate.

The Council has made "The Clackmannanshire Council (Lower Mill Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 29<sup>th</sup> August 2018: where there will be a temporary prohibition of driving, parking and loading at **Lower Mill Street** (from its junction with Barnpark Drive southwards until its junction with Hareburn Road, a distance of 125 metres or thereby). Diversion : Via A908, A91 and vice versa. The order runs from 0800 hours on Monday 1<sup>st</sup> October 2018 for a period of 1 week or until works are completed whichever is soonest. The works are necessary to allow the drainage works to be carried out. Diversion will be signed where appropriate. 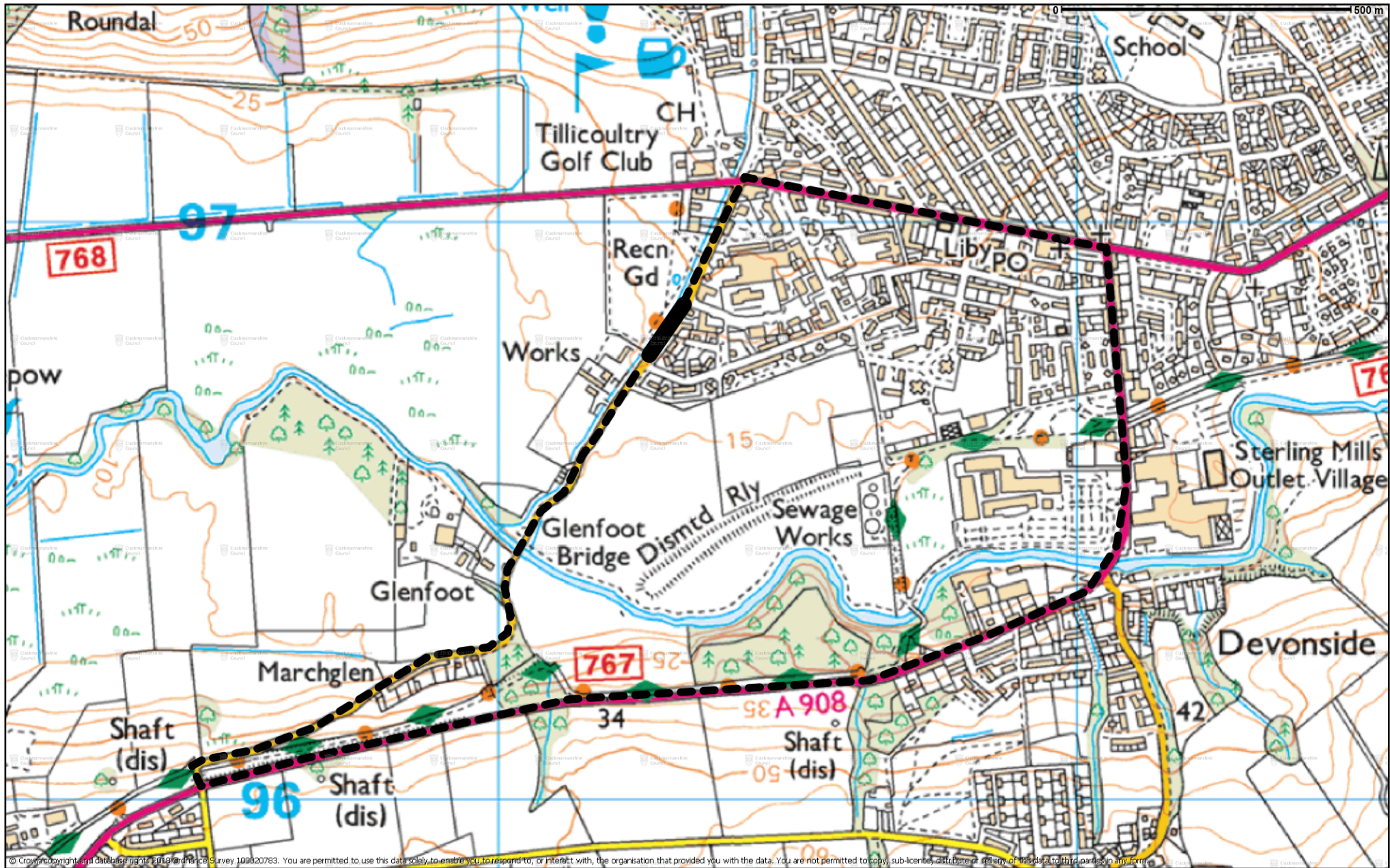
