



**(BURGH MEWS, ALLOA)

1. This Order may be cited as "The Clackmannanshire Council (Street, Town) (Temporary No Parking) Order 2018" and notwithstanding the date hereof shall come into operation at 0600 hours on Tuesday 2nd October 2018 and will remain in operation until 1500 hours on that day.

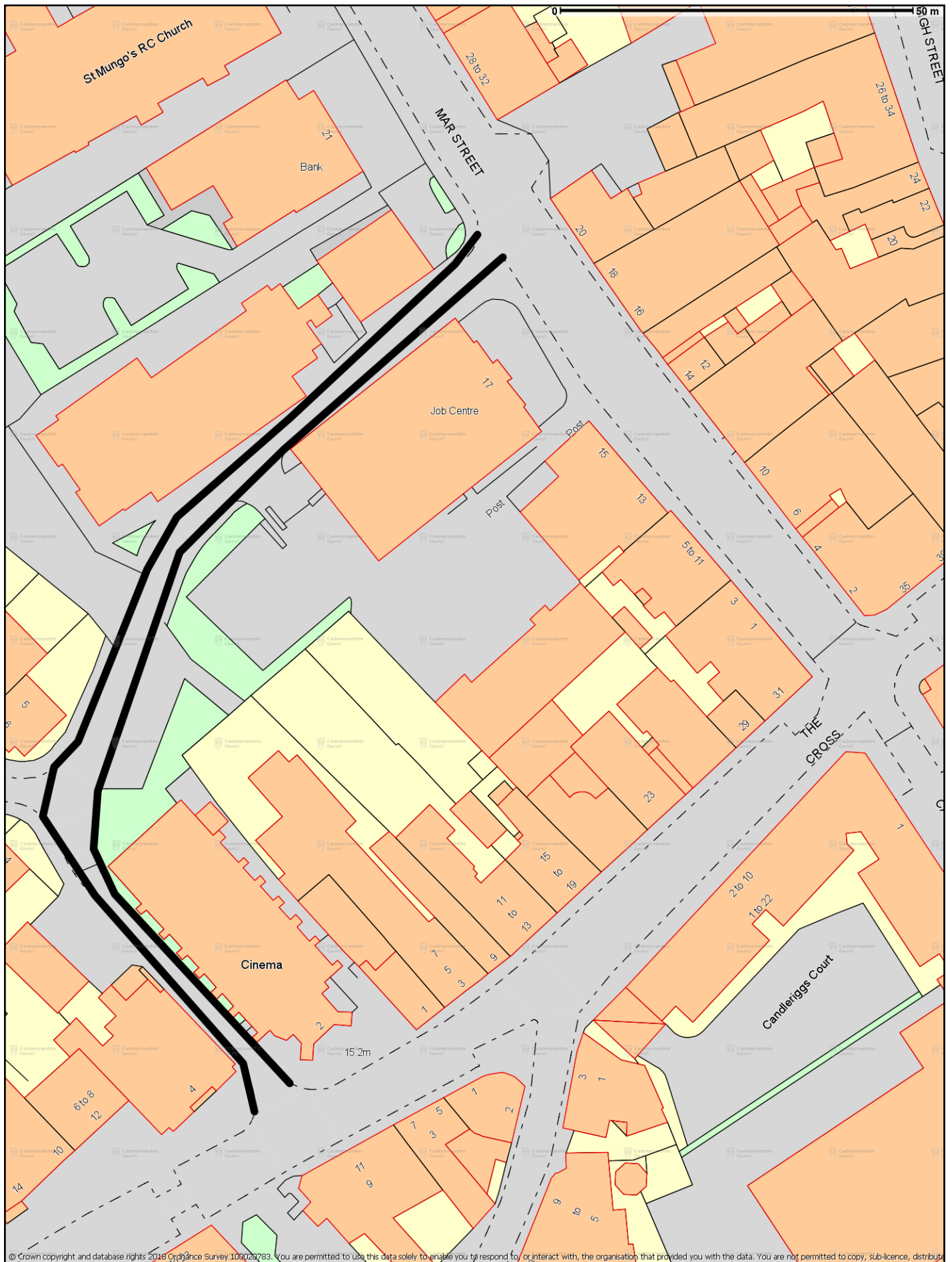
