



**(COPLAND PLACE, ALVA)

1. This Order may be cited as "The Clackmannanshire Council (Copland Place, Alva) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 15<sup>th</sup> October 2018 and will remain in operation for one week.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 15<sup>th</sup> October 2018 for a period of one week or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary due to resurfacing works at A91 Stirling Street.


