The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Revocation of One Way) Order 2018" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 15<sup>th</sup> October 2018 and will remain in operation for a period of one week.
2. The effect of this Order shall be to suspend one way during:-

The period from 0800 hours on Monday 15<sup>th</sup> October 2018 for a period of one week or until works are completed whichever is soonest, on the sections of roads described in Schedule. The temporary revocation of one way is to allow 2 way vehicle movement during resurfacing works.

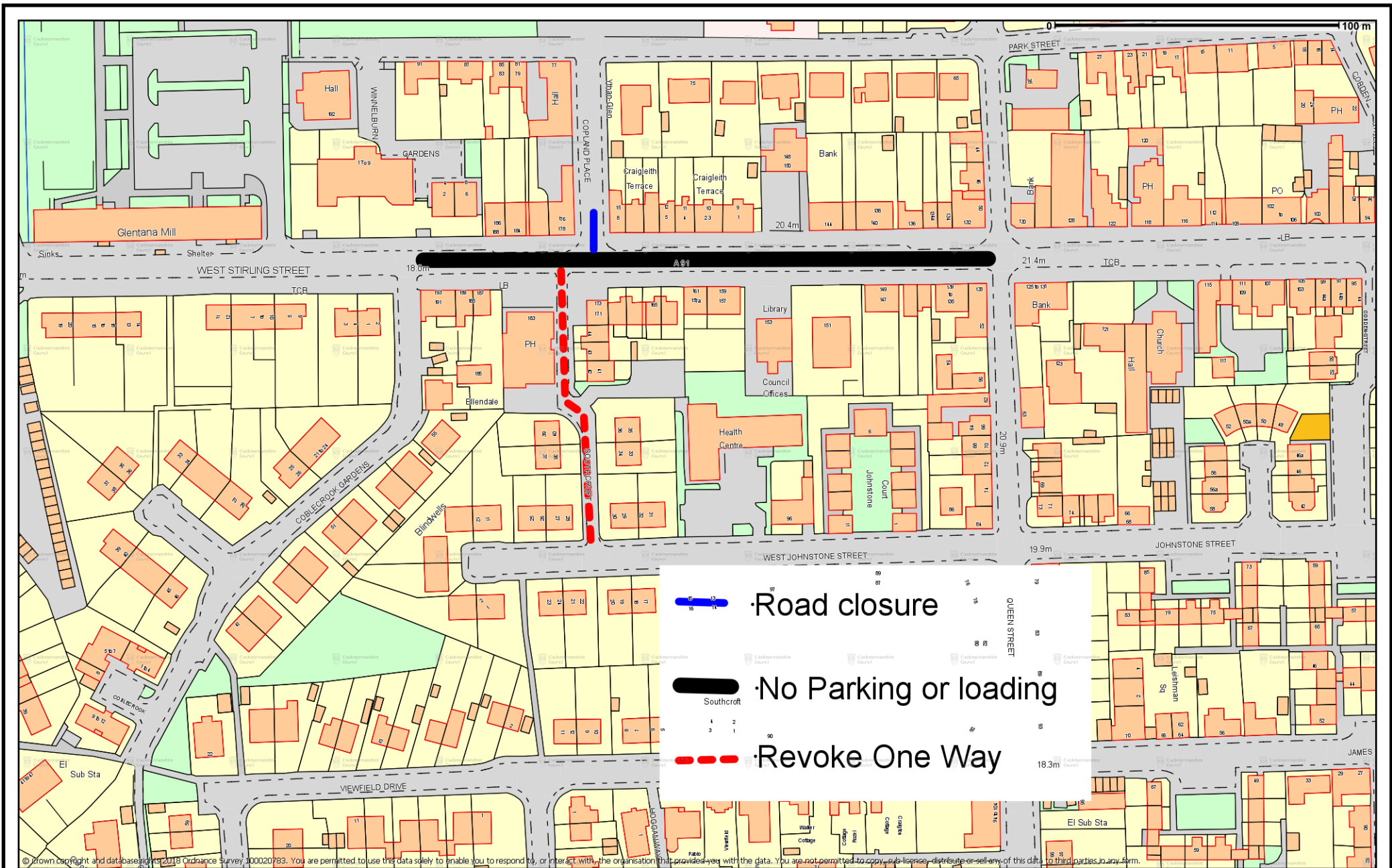
