



**(WHINS ROAD, ALLOA)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Whins Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 29<sup>th</sup> October 2018 and will remain in operation for one week.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 29<sup>th</sup> October 2018 for a period on one week, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow the footway to be surfaced.

The Council has made "The Clackmannanshire Council (Whins Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 20<sup>th</sup> September 2018: where there will be a temporary prohibition of driving, parking and loading at **Whins Road, Alloa** (Southbound – from a point 10 metres or thereby north of its junction with Argyll Place southwards for a distance of 200 metres or thereby). Diversion: Via B909, A907. The order runs from 0900 hours Monday 29<sup>th</sup> October 2018 for a period of one week. The works are necessary to allow the footway to be surfaced. 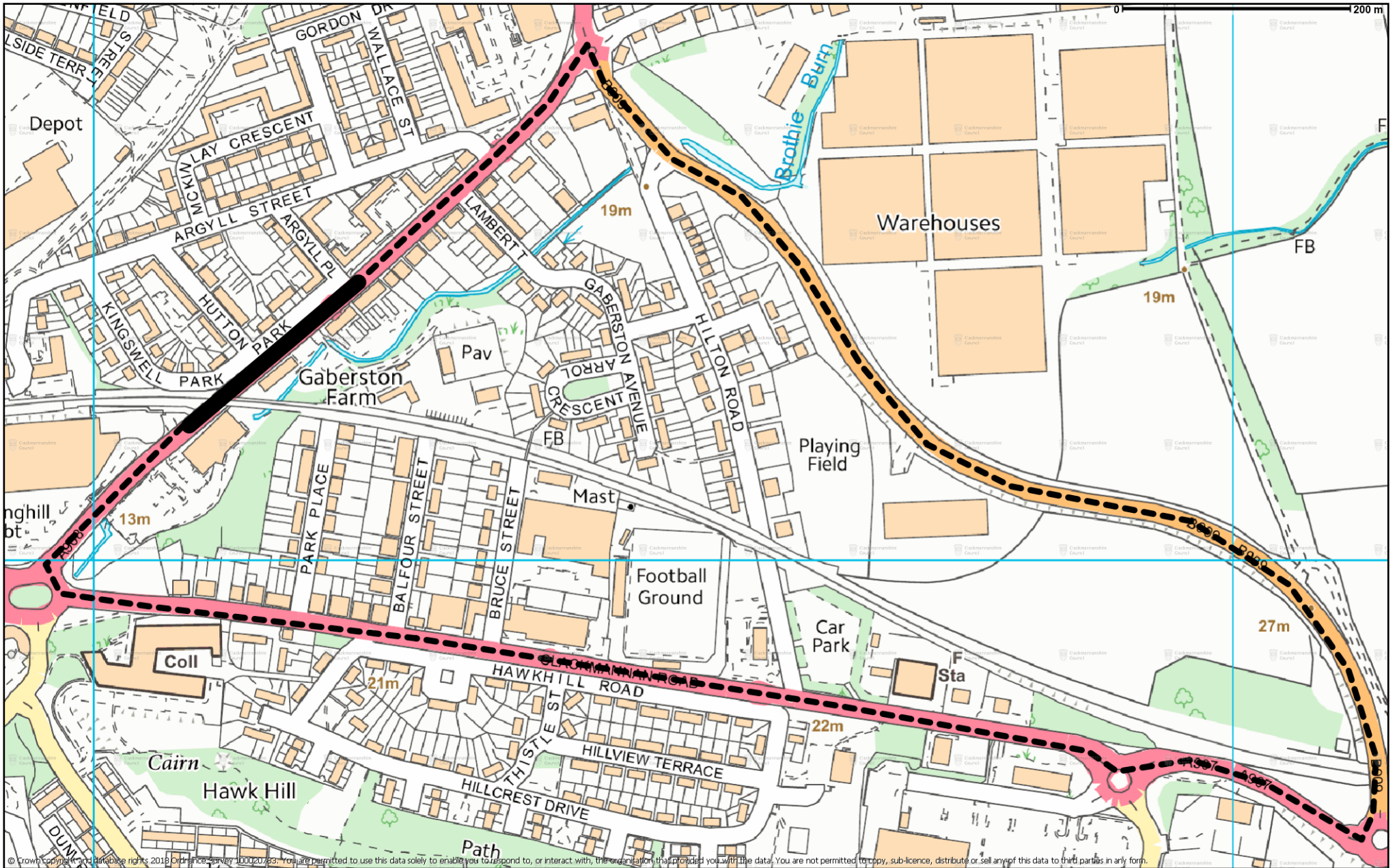
