



**(THE BRAES, TULLIBODY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (The Braes, Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2018" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours on Monday 5th November 2018 and will remain in operation for one week.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0900 hours on Monday 5th November 2018 for a period on one week, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow the road to be surfaced. Access for residents where possible during works. No access to Blackmuir Place/The Braes on one day during works 0900 hours – 1600 hours. This will be signed on site.


