



**(MEEKS PARK ROAD, FORESTMILL)
(TEMPORARY ROAD CLOSURE) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Meeks Park Road, Forestmill) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Thursday 27th December 2018 and will remain in operation for a period of 8 days.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0800 hours on Thursday 27th December 2018 for a period of 8 days or until works are complete whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary for installation of power to the site.

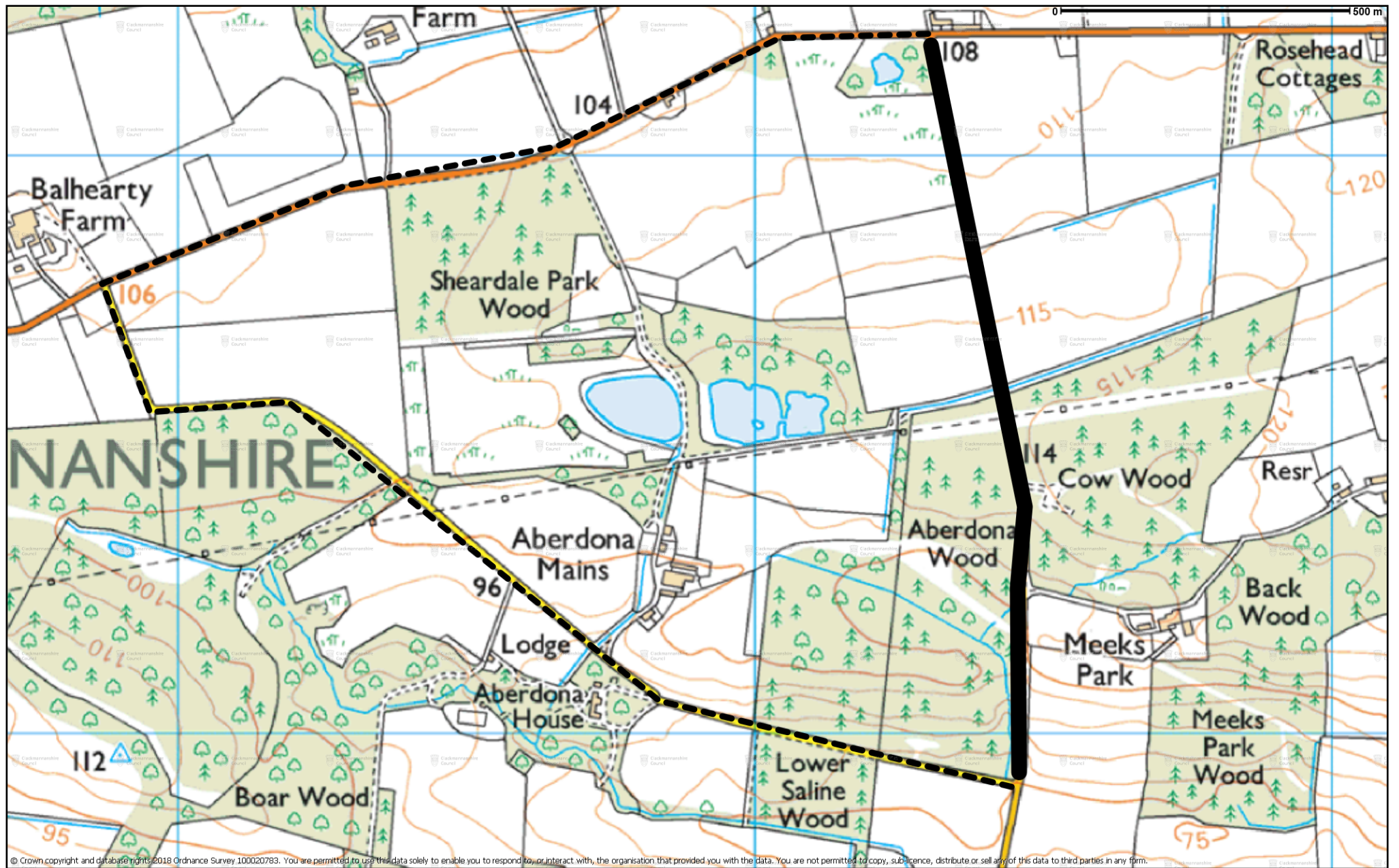
