**(MAIN STREET, CLACKMANNAN)
(ONE-WAY TRAFFIC) ORDER 2019**

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4(1), 9 and 10(2) of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Parts III and IV of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Clackmannanshire Council (Main Street, Clackmannan) (One-Way Traffic) Order 2019" and shall come into operation on the 22 March 2019.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive or cause or permit to be driven any vehicle on the length of road specified in the Schedule to this Order other than in the direction specified in the said Schedule and shown on the plan annexed and signed as relative hereto
4. Nothing in Article 3 of this Order shall apply to the driving of any mechanical road cleansing vehicle or any vehicle used for fire brigade purposes, or any ambulance or any vehicle in the service of a local police force being used in pursuance of statutory powers or duties.
5. Nothing in Article 3 of this order shall apply to a pedal cycle proceeding in either direction in Main Street, between Kirk Wynd and Castle Street

6. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

The Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 4(1), 9 and 10(2) and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate **Main Street, Clackmannan** (From its junction with Kirk Wynd eastwards until its junction with Castle Street, a distance of 200 metres or thereby) as a One Way Traffic System with the permitted direction – West to East and is required to reduce traffic congestion in the area. Objectors must state their reasons in writing to Gillian White, Legal and Democracy, Kilncraigs, Alloa, FK10 1EB by 15/02/19. The Council has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 9 and 10(2) and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate **Main Street, Clackmannan** (From its junction with Kirk Wynd eastwards until its junction with Castle Street, a distance of 200 metres or thereby) as a One Way Traffic System with the permitted direction – West to East and is required to reduce traffic congestion in the area. Anyone wishing to question the validity of any of the provisions within this order should write to the Court of Session within six weeks of 13/03/19. The Clackmannanshire Council has made the above named Order under Sections 1(1), 2(1) to (3), 4(1), 9 and 10(2) and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 on 1 March 2019.

FULL DETAILS of this Order is as published in the Alloa Advertiser on 16 January 2019, and will designate the sections of roads described in the Schedule as a One Way Traffic System which is required to reduce traffic congestion within the area. The Order will come into effect on 22 March 2019.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that if any requirement therein has not been complied with, may, within six weeks from 13 March 2019 apply to the Court of Session for this purpose.
