During the period from 0800 hours on Monday 25<sup>th</sup> February 2019, on the section of roads described in Schedule. The temporary closure is necessary for Openreach installation of new cabling for customer connection.

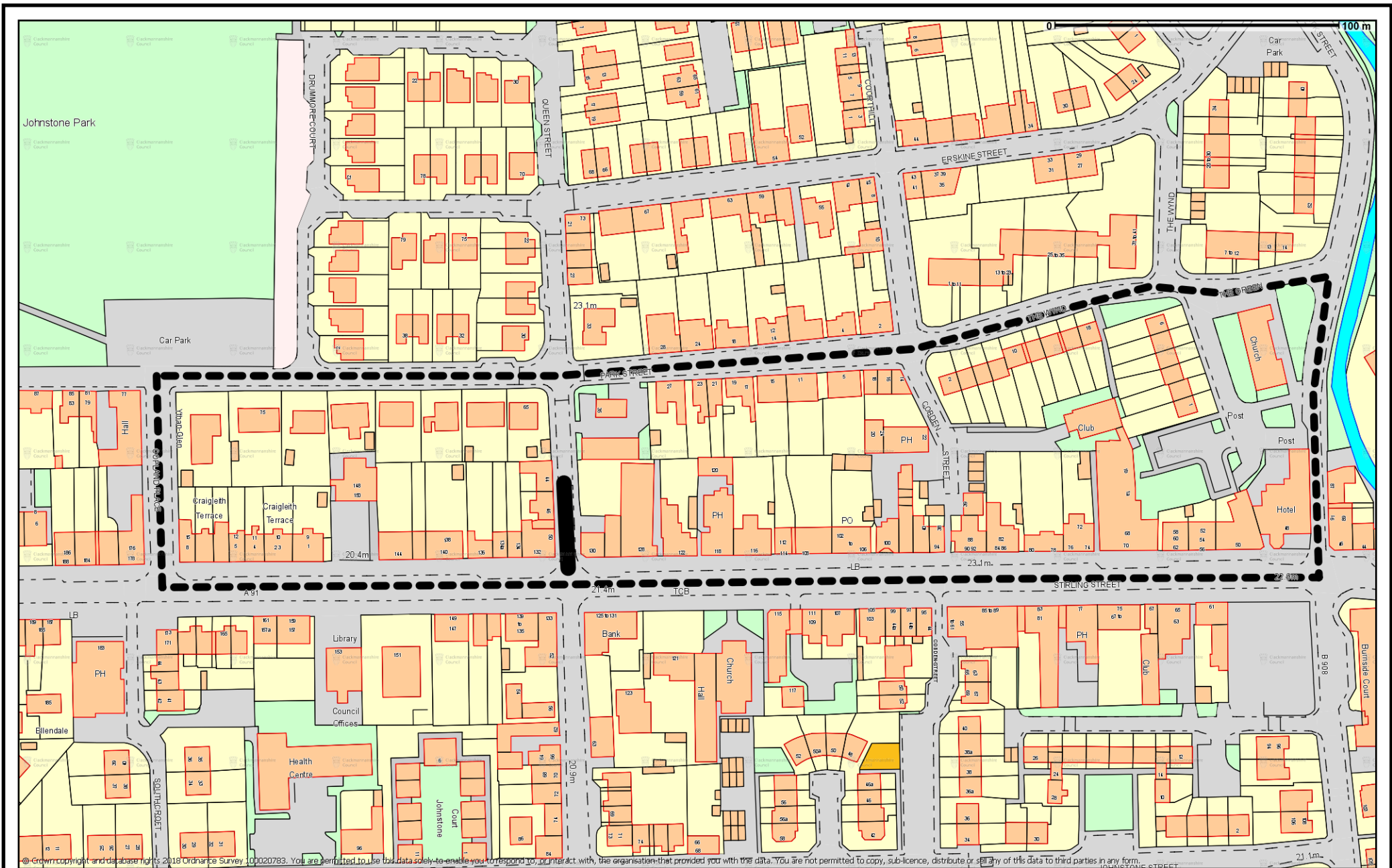
