This Order may be cited as "The Clackmannanshire Council (A908 Fishcross-Devonside) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 1000 hours on Sunday 31<sup>st</sup> March 2019 and will remain in operation until 1230 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

The period from 1000 hours until 1230 hours on Sunday 31<sup>st</sup> March 2019, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.

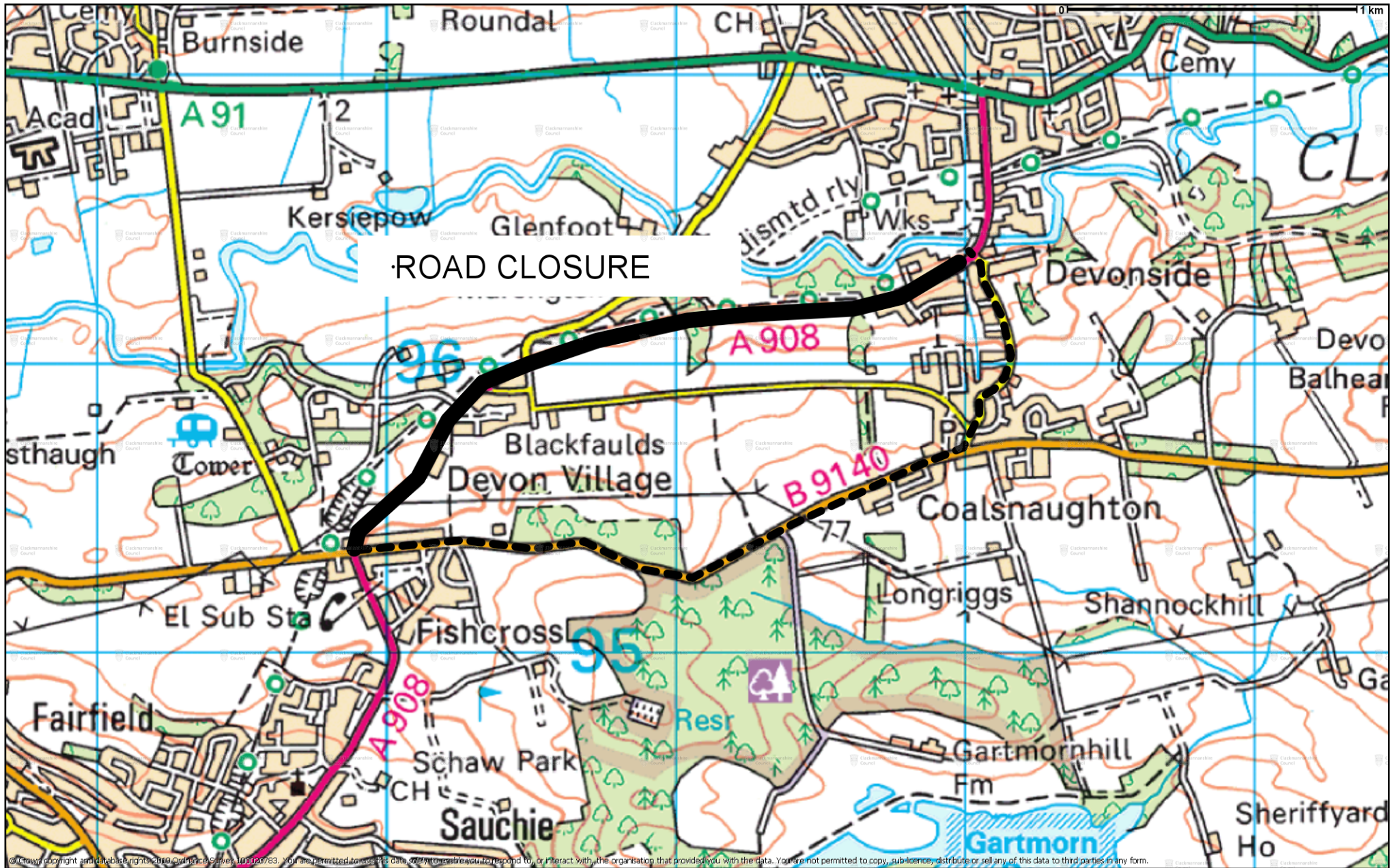
