



**(ALLOA HALF MARATHON)
(TEMPORARY ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Alloa Half Marathon) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 1000 hours on Sunday 31st March 2019 and will remain in operation until 1130 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

The period from 1000 hours until 1130 hours on Sunday 31st March 2019, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.

The Council has made "The Clackmannanshire Council (Alloa Half Marathon) (Temporary Road Closure) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 18th February 2019: to close to vehicles the section of road at **A908 Hallpark** (Northbound only: from its junction with Whins Road Roundabout northwards until its junction with B908 Fairfield, Sauchie, for a distance of 530 metres or thereby). The order runs from 1000 hours until 1130 hours on Sunday 31st March 2019 and is necessary to facilitate the safe passage of participants in the Alloa Half Marathon. 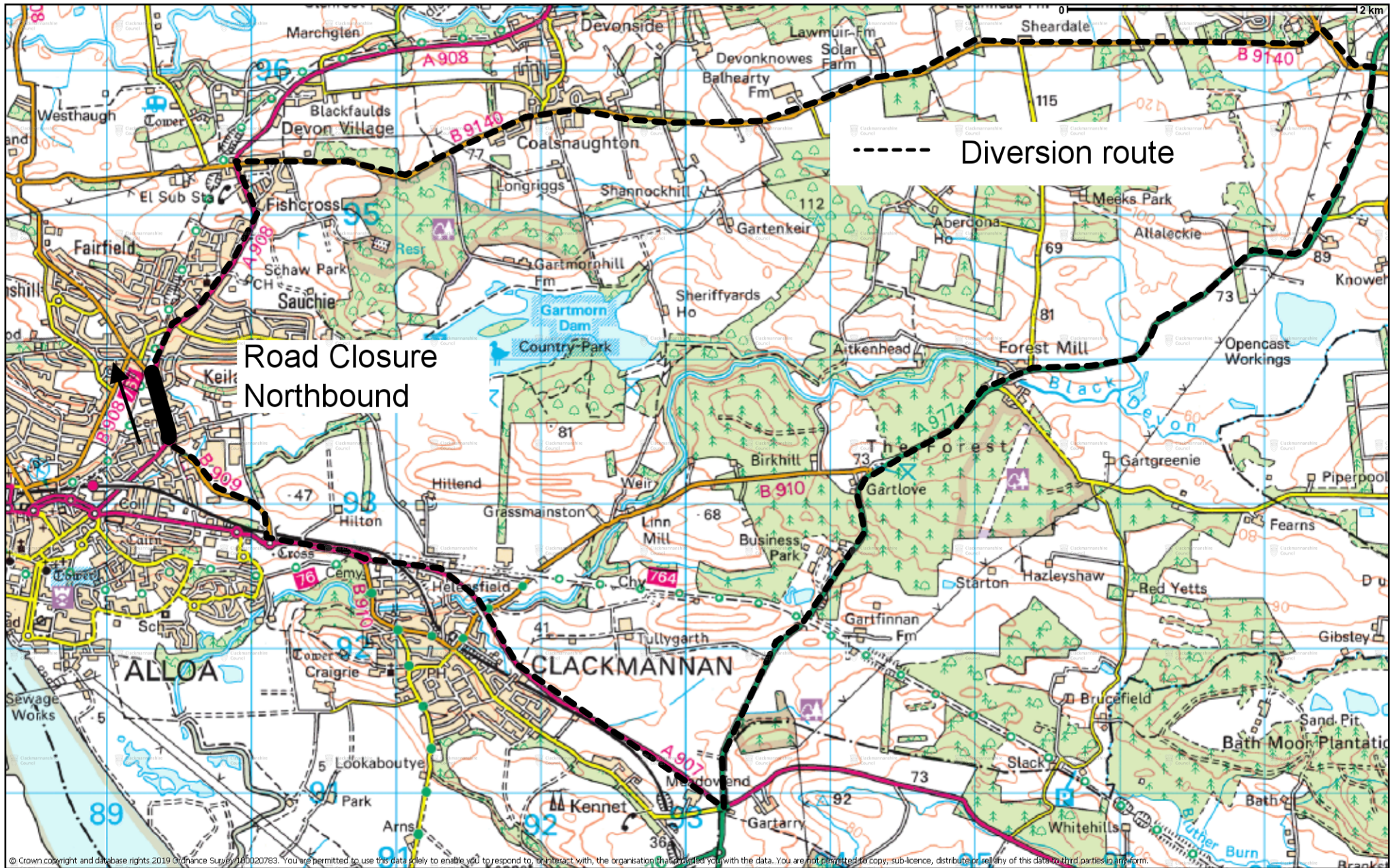
