



**(A907 KELLIE PLACE, ALLOA)  
(TEMPORARY ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Kellie Place, Alloa) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 1<sup>st</sup> April 2019 and will remain in operation for a period of 7 days.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0800 hours on Monday 1<sup>st</sup> April 2019 for a period of 7 days or until works are complete whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary for footway/carrageway improvements. Residents will be notified of timescales and available access during the works.

The Council has made "The Clackmannanshire Council (A907 Kellie Place, Alloa) (Temporary Road Closure) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 4<sup>th</sup> March 2019: to close to vehicles the section of road at **A907 Kellie Place, Alloa** (from its junction with Ludgate roundabout westwards then eastwards for a distance of 330 metres or thereby), **A907 Ludgate, Alloa** (from its junction with Kellie Place southwards until its junction with Ludgate roundabout, a distance of 110 metres or thereby). Alternative route: Via A907, Alexandra Drive, Victoria Street, B9096 and vice Versa. Alternative route for HGV's: Via B9096 from Dumyat Park roundabout or Marshall roundabout. The order runs from 0800 hours on Monday 1<sup>st</sup> April 2019 for a period of 7 days or until works are complete whichever is soonest and is necessary for footway/carriageway improvements. Residents will be notified of timescales and available access during the works. 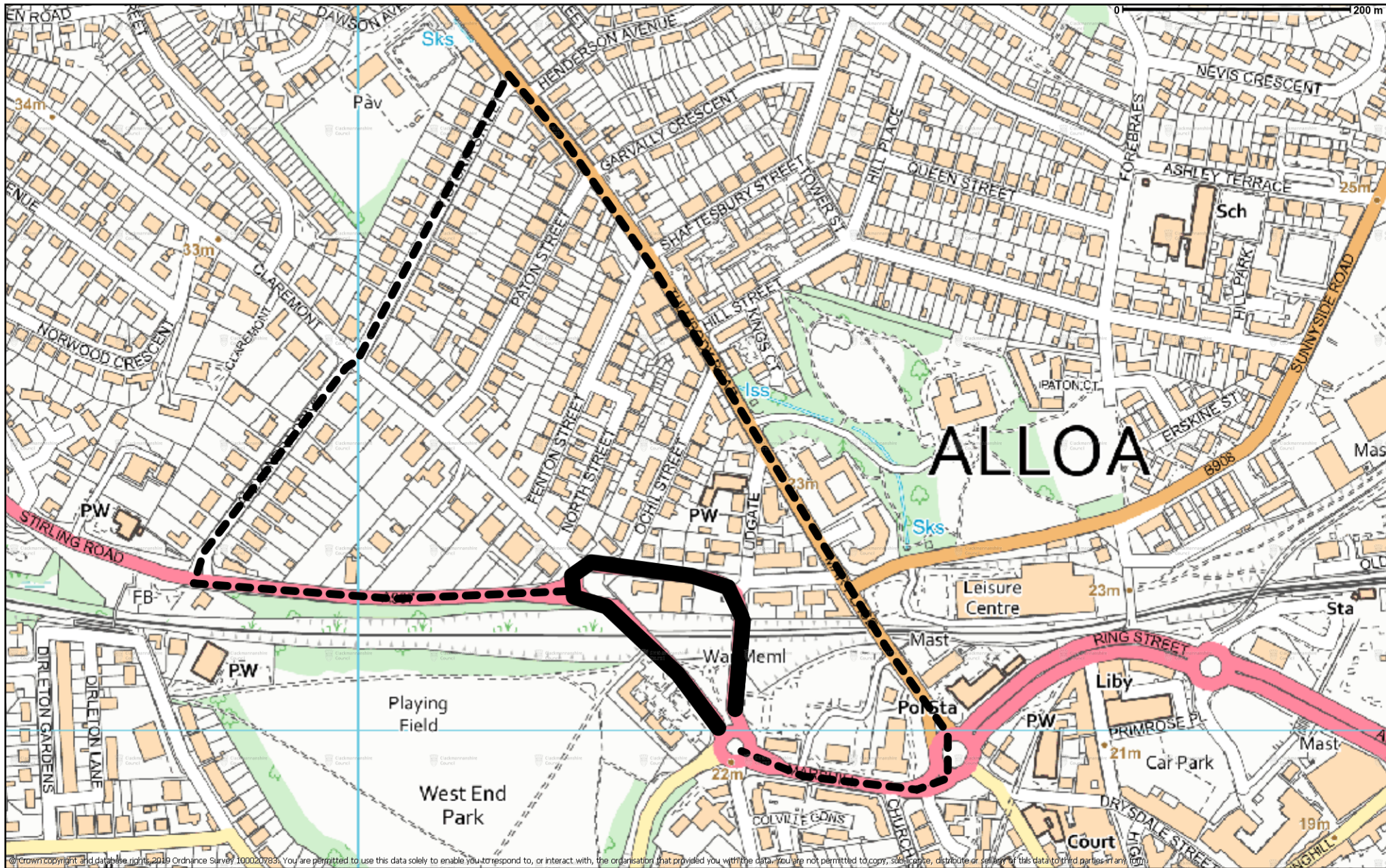
