



**(STANTON AVENUE, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Stanton Avenue, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 22nd April 2019 and will remain in operation until 1600 hours on Friday 25th April, 2019.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 22nd April 2019 until 1600 hours on Friday 25th April 2019, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow for carriageway resurfacing and associated kerbing works. Access only for residents.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 25th March 2019: where there will be a temporary prohibition of driving, parking and loading at **Stanton Avenue** (for its entirety, a distance of 125 metres or thereby). Diversion: Via Forbes Street, Bellevue Road, Caledonian Road and vice versa. The order runs from 0800 hours on Monday 22nd April 2019 until 1600 hours on Friday 25th April 2019. The works are necessary to allow resurfacing works. Access will be available for residents where possible. 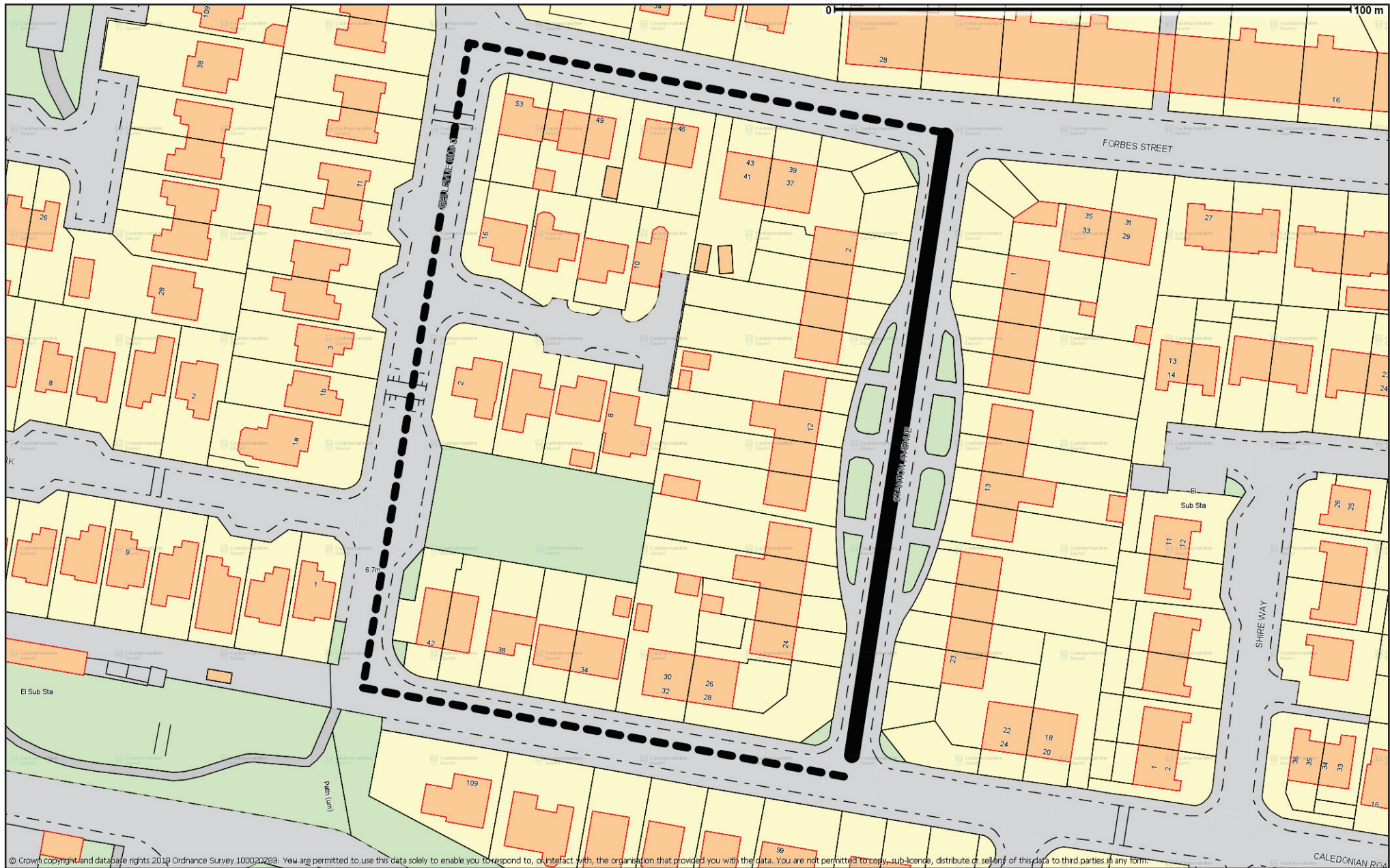
