



**(COBDEN STREET, ALVA)
(TEMPORARY ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Cobden Street, Alva) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 0900 hours on Tuesday 14th May 2019 and will remain in operation until 1600 hours on Friday 17th May 2019.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0900 hours on Tuesday 14th May 2019 until 1600 hours on Friday 17th May 2019, on the section of roads described in Schedule. The temporary closure is necessary to allow a new gas connection to be installed.

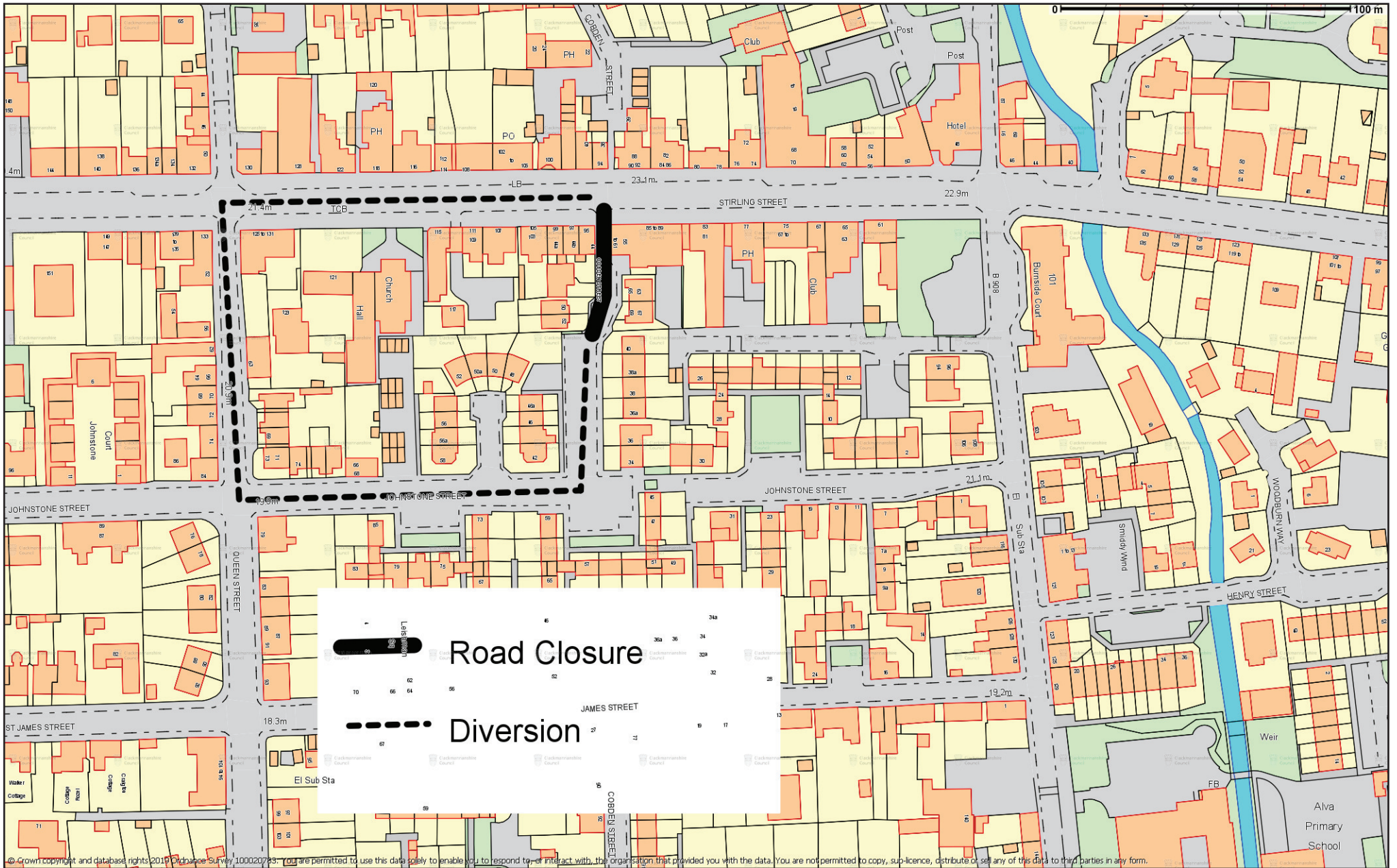
