



**(PARKING SPACES FOR DISABLED PERSONS)

The Clackmannanshire Council in exercise of its powers under Sections 32(1) and 35(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:

1. This Order may be cited as "The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Revocation No. M4, Elmbank, Menstrie) Order 2019" and shall come into operation on the 7 August 2019.
2. The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Menstrie) Order 2015 is hereby revoked, in so far as it relates to No. M4, Elmbank, Menstrie.
