

(DRYSDALE STREET, ALLOA) (TEMPORARY NO WAITING RESTRICTION) ORDER 2019

- This Order may be cited as "The Clackmannanshire Council (Drysdale Street, Alloa) (Temporary No Waiting Restriction) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Friday 31st May 2019 and will remain in operation until 1030 hours on that day.
- 2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 0800 hours until 1030 hours on Friday 31st May 2019, on the section of roads described in Schedule. The temporary no waiting is necessary to facilitate Armed Forces Day.
