

(HIGH STREET, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (High Street, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0700 hours until 1800 hours on following dates: Friday 7th June 2019, Friday 5th July 2019, Friday 2nd August 2019, Friday 6th September 2019, Friday 4th October 2019, Friday 1st November 2019 and Friday 6th December 2019.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0700 hours until 1800 hours on the following dates – Friday 7th June 2019, Friday 5th July 2019, Friday 2nd August 2019, Friday 6th September, Friday 4th October 2019, Friday 1st November 2019 and Friday 6th December 2019, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow monthly market to take place. Access will be allowed for emergency services.
