



**(MILL STREET, ALLOA)
(TEMPORARY REVERSAL OF ONE WAY) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Mill Street, Alloa) (Temporary Suspension of One Way) Order 2019" and notwithstanding the date hereof shall come into operation at 0700 hours until 1800 hours on the following dates:

Friday 7th June 2019, Friday 5th July 2019, Friday 2nd August 2019, Friday 6th September 2019, Friday 4th October 2019, Friday 1st November 2019 and Friday 6th December 2019.

2. The effect of this Order shall be to reverse one way traffic during:-

The period from 0700 hours until 1800 hours on the following dates – Friday 7th June 2019, Friday 5th July 2019, Friday 2nd August 2019, Friday 6th September 2019, Friday 4th October 2019, Friday 1st November 2019 and Friday 6th December 2019, on the sections of roads described in Schedule. The temporary one way suspension is necessary to allow access to the taxi rank.


