



**(VARIOUS STREETS, TULLIBODY)
(TEMPORARY ROLLING ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Tullibody) (Temporary Rolling Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 1600 hours on Saturday 6th July 2019 and will remain in operation until 1630 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 1600 hours until 1630 hours on Saturday 6th July 2019, on the section of roads described in Schedule. The temporary closure is required to facilitate a procession for the Kenneth Aitken Memorial District Lodge Parade. The rolling road closure will assist Police Scotland in their duties.

The Council has made "The Clackmannanshire Council (Various Streets, Tullibody) (Temporary Rolling Road Closure) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 23rd May 2019: to close to vehicles the section of road at **Abercrombie Place** (from its junction with the Civic Centre until its junction with Main Street, a distance of 92 metres or thereby), **Main Street** (from its entirety, a distance of 332 metres or thereby), **Ochil Street** (from its junction with Main Street until its junction with Newmills, a distance of 60 metres or thereby), **Newmills** (from its junction with Ochil Street until its junction with Baingle Brae, a distance of 173 metres or thereby), **Baingle Brae** (from its junction with Newmills until its junction with Stirling Road, a distance of 214 metres or thereby), **Stirling Road** (from its junction with Baingle Brae until its junction with Main Street, a distance of 327 metres or thereby). The order runs from 1600 hours until 1630 hours on Saturday 6th July 2019 and is required to facilitate a procession for the Kenneth Aitken Memorial District Lodge Parade. 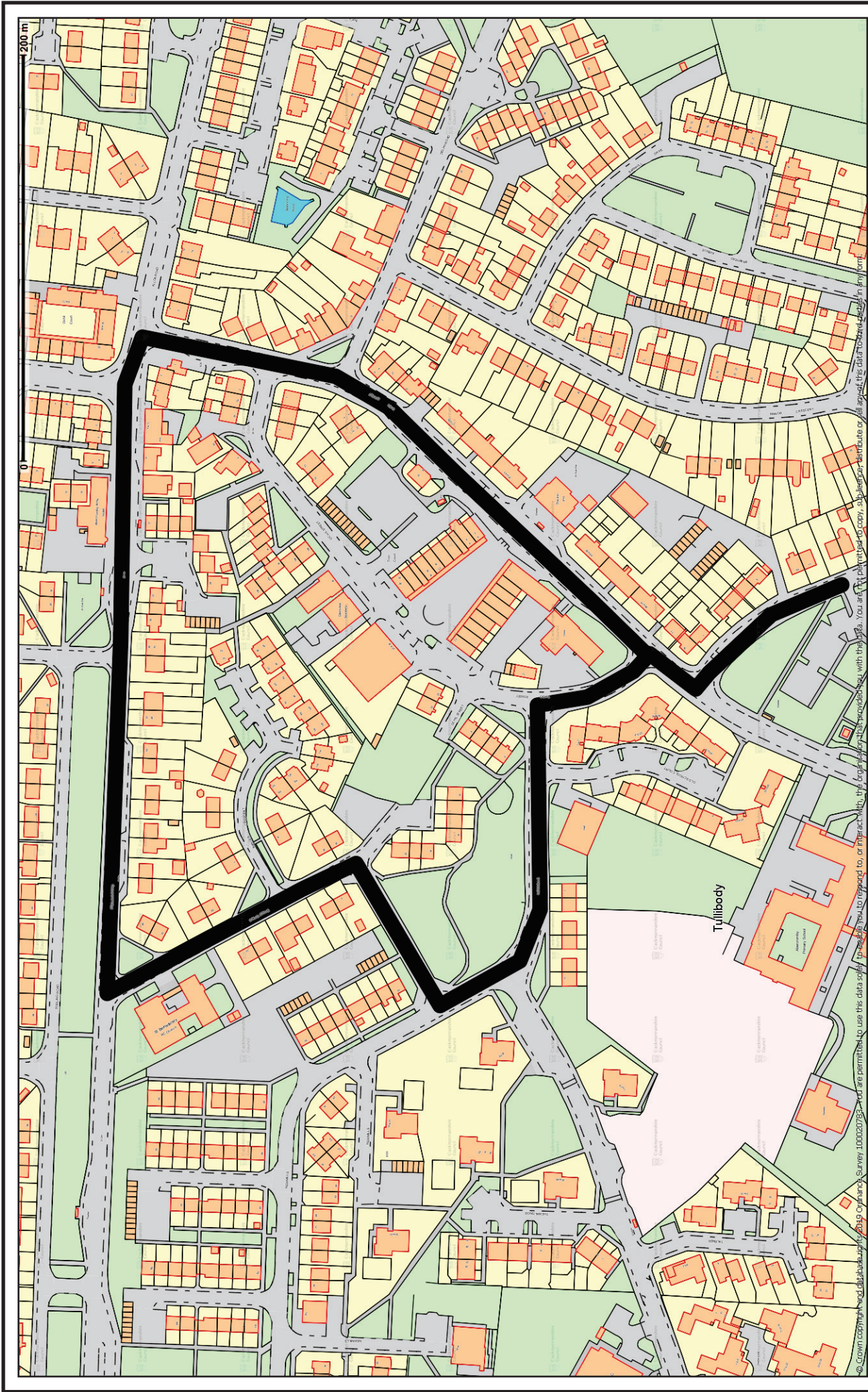
