



**(DICKIES WELLS AND RHODDERS GROVE, ALVA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Dickies Wells and Rhodders Grove, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 8th July 2019 and will remain in operation until 1600 hours on Sunday 14th July 2019.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 8th July 2019 until 1600 hours on Sunday 14th July 2019, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow carriageway resurfacing. Access will be allowed for residents where possible.

The Council has made "The Clackmannanshire Council (Dickies Wells and Rhodders Grove, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 5th June 2019 : where there will be a temporary prohibition of driving, parking and loading at **Dickies Wells, Alva** (from its junction with A91 Stirling Street north eastwards for a distance of 130 metres or thereby); **Rhodders Grove, Alva** (from its junction with Dickies Wells westwards for a distance of 40 metres or thereby). The order runs from 0800 hours on Monday 8th July 2019 until 1600 hours on Sunday 14th July 2019. The works are necessary to allow carriageway resurfacing. Access will be allowed for residents where possible.
