



**(HENRY STREET, ALVA)
(TEMPORARY REVOCATION OF ONE WAY) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Henry Street, Alva) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 8th July 2019 and will remain in operation until 1700 hours on Tuesday 20th August 2019.
2. The effect of this Order shall be to suspend one way traffic during:-

The period from 0800 hours on Monday 8th July 2019 until 1700 hours on Tuesday 20th August 2019, on the sections of roads described in Schedule. The temporary one way suspension is necessary to allow 2 way vehicle movements during the Alva Regeneration Project works.

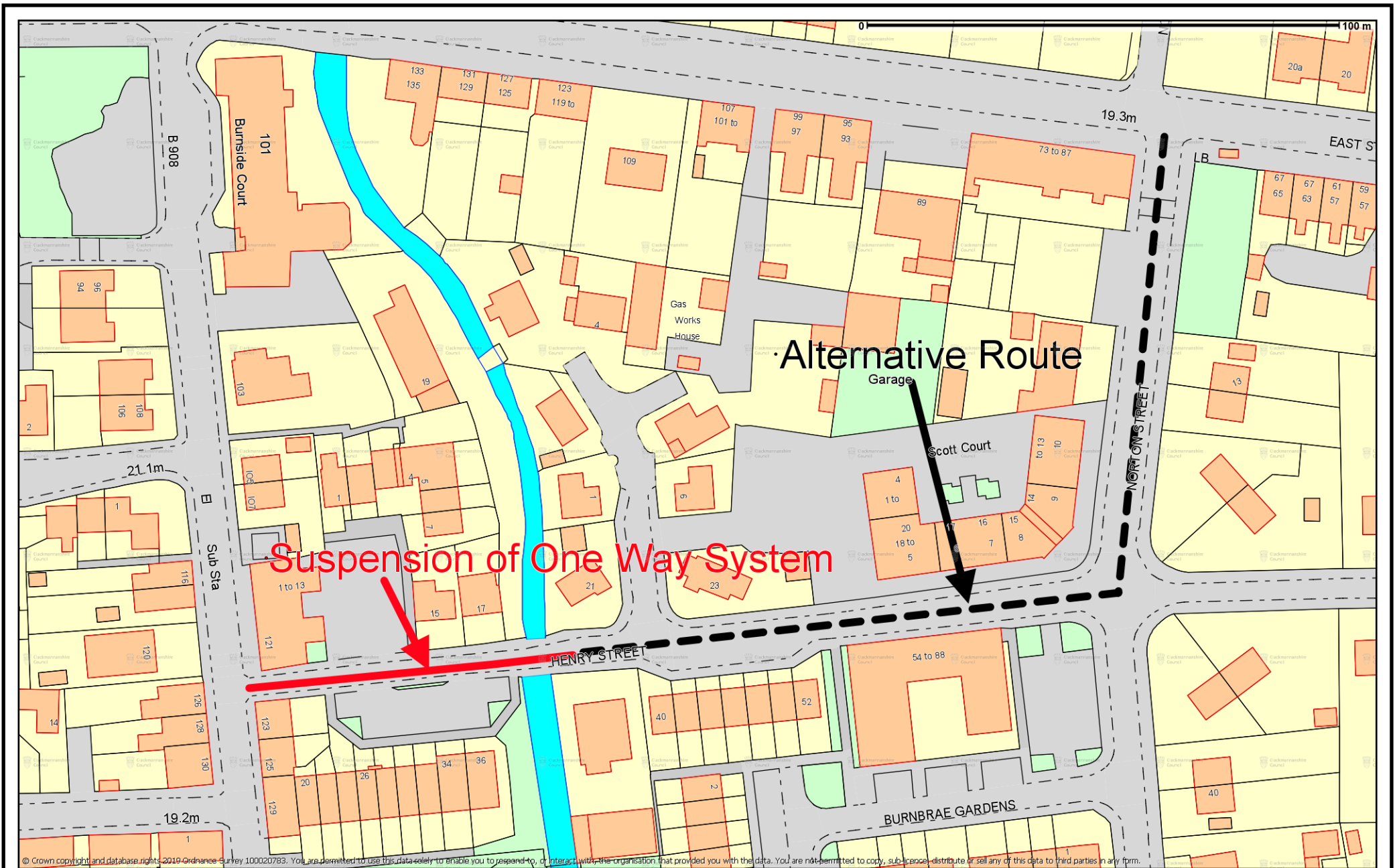
