1. This Order may be cited as "The Clackmannanshire Council (Deerpark, Sauchie) (Temporary No Parking Restriction) Order 2019" and notwithstanding the date hereof shall come into operation at 0700 hours on Thursday 5<sup>th</sup> September 2019 and will remain in operation until 1900 hours on Monday 9<sup>th</sup> September 2019.
2. The effect of this Order shall be to suspend parking during:-  
The period from 0700 hours on Thursday 5<sup>th</sup> September 2019 until 1900 hours on Monday 9<sup>th</sup> September 2019, on the section described in the Schedule attached. The temporary parking suspension is required for Scottish Power link box replacement works.

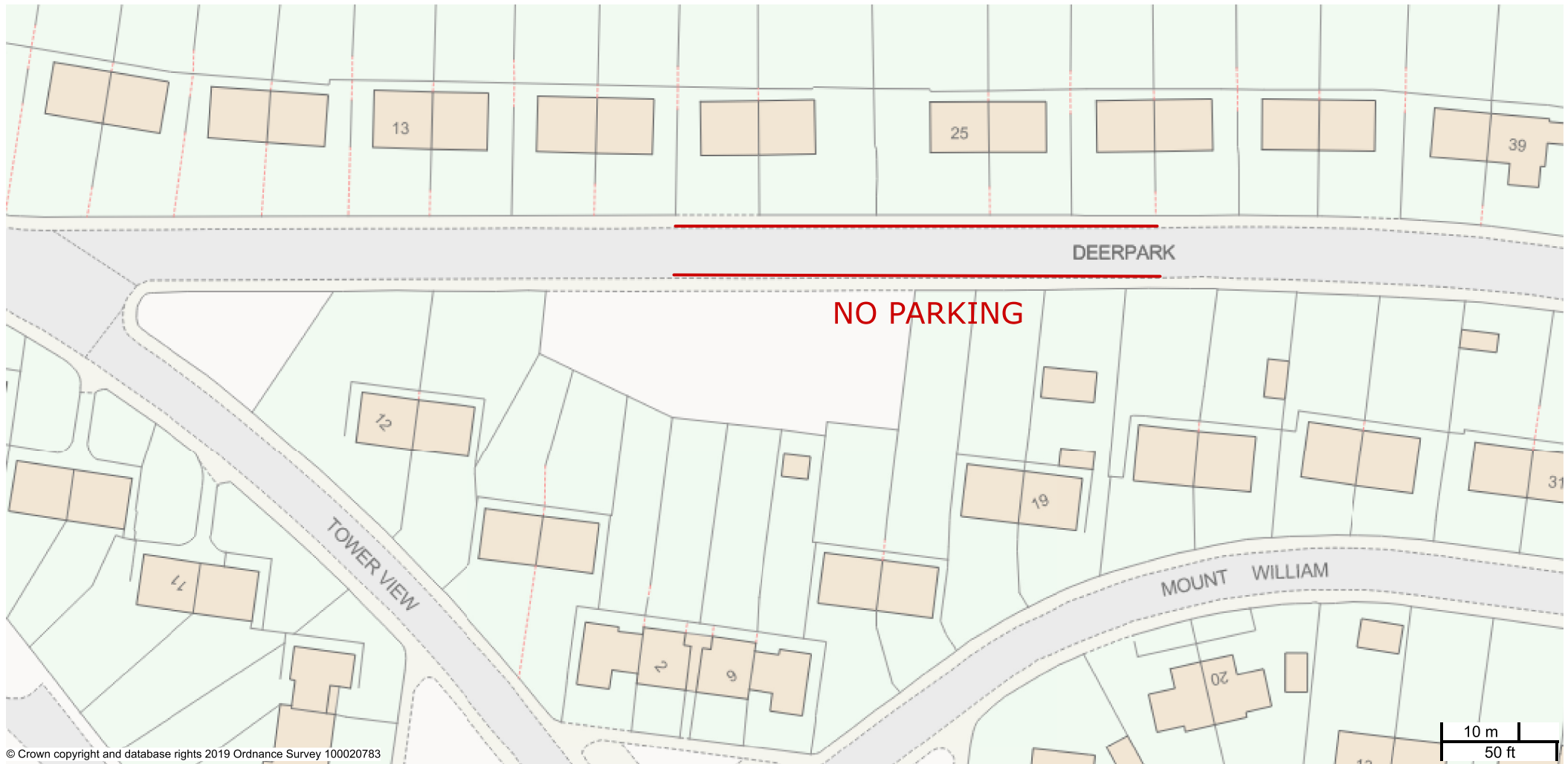
