



**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROLLING ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Rolling Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 1100 hours on Saturday 14th September 2019 and will remain in operation until 1230 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 1100 hours until 1230 hours on Saturday 14th September 2019, on the section of roads described in Schedule. The temporary closure is required for Police Scotland to carry out their duties and for safe pass of the procession.

The Clackmannanshire Council (Various Streets, Alloa) (Temporary Rolling Road Closure) Order 2019

The Council has made "The Clackmannanshire Council (Street, Town) (Temporary Rolling Road Closure) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 22nd August 2019: to close to vehicles the section of road at **King Street, Alloa** (from a point 90 metres west of its junction with Shillinghill Roundabout westwards until its junction with Primrose Street, a distance of 217 metres or thereby), **Primrose Street, Alloa** (For its entirety, a distance of 130 metres or thereby), **Drysdale Street, Alloa** (from its junction with Primrose Street eastwards until its junction with High Street, a distance of 35 metres or thereby), **High Street, Alloa** (For its entirety, a distance of 115 metres or thereby), **Mil Street, Alloa** (from its junction with High Street westwards until its junction with Mar Street, a distance of 42 metres or thereby), **Greenside Street, Alloa** (from its junction with Auld Brig Road southwards for a distance of 20 metres or thereby). The order runs from 1100 hours until 1230 hours on Saturday 14th September 2019 and is required for Police Scotland to carry out their duties and for safe pass of the procession.
